11) DELIVERY SCHEDULE OF SUPPLY:

Supply shall be made in staggered delivery basis in four lots. 1st lot 25% of the order quantity shall be suppli ed within two months from the placement of purchase order and the balance of materials shall be supplied in three batches, within next three months interval.

12) Acceptance:

The bags shall be accepted on the basis of the test report, physical measurement a t site for length, width, and weight and drop test. Allowable tolerance as per relevant IS specification is applicable. Total lot will be accepted on weight basis only.

13) Rejection:

Acceptance of the Lot does not absolve the supplier from the performance of the ba gs. Any bags not meeting the specification and fails during use, the total lot shall be rejected and supplier shall replace the material free of cost and the transportation of the material for return and replacement shall be borne by the supplier. If bursting is found beyond 0.10%, lot will not be used and same will be rejected. With actual use of bags during bagging operations, if performance of bags is not found satisfactory, the lot will be rejected.

- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
