- 1. #### 1. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates

(whichever is lower), subject to the maximum of quoted GST %.

### 2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

#### 3. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

#### 4. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

# 5. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

#### 6. Scope of Supply

#### 7. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. #### 1. <u>Delivery schedule:</u>

- i) 1st lot of 4000 MT coal shall be supplied through rake within 30 days from date of order.

2) **Transit Loss:** Transit loss, if any, will be in your account.

#### 3) **FORCE MAJEURE:**

3.1 Force majeure is an event beyond the control of SELLER and not involving the SELLER's f ault or negligence and which is not foreseeable, which prevents the SELLER from fulfillin g its obligations under the CONTRACT.

Force Majeure shall mean and be limited to the following:

- a) War/hostilities
- b) Riot or Civil commotion
- c) Earthquake, flood, tempest, lightening or other natural physical disaster.
- d) Restrictions imposed by the Government or other statutory bodies which prevent or dela y the execution of the Contract by the SELLER.

The decision as to whether an event constitutes force majeure shall rest with PURCHASER w hich shall be final and binding.

- 3.2 If there is delay in performance or other failures by the SELLER to perform obligations u nder the contract due to event of a Force Majeure, the SELLER shall not be held responsible for such delays/failures.
- 3.3 If a Force Majeure situation arises, the SELLER shall promptly notify the purchaser in writing of such conditions and the cause thereof within fifteen days of occurrence of such event. Unless otherwise directed by the Purchaser in writing, the SELLER shall continue to perform its obligations under the contract as far as reasonable/practical and shall seek all reasonable alternative means for performance not prevented by the Force Majeure event.
- 3.4 If the performance in whole or in part or any obligation under this contract is prevented or delayed by any reason of Force Majeure for a period of exceeding 120 days, PURCHASER may at its option terminate the contract without any financial repercussion on either side.

#### 4) Liquidated damages:

For delays attributable to you, LD shall be levied @0.5 % of the prices of any portion of s tores delivered late, for each week or part thereof of delay. The total damages shall not exceed 10 % of the value of delayed goods. The LD cannot exceed the amount stipulate d in the contract.

IREL (India) Limited may deduct the amount so payable by you, from any amount falling due to you or by recovery against the Performance Guarantee. Both you and IREL agree that the above percentages of price reduction are genuine pre-estimates of the loss/da mage which the IREL would have suffered on account of delay/breach on the part of you and the said amount will be payable on demand without there being any proof of the act ual loss/or damage caused by such breach/delay. A decision of the IREL in the matter of applicability of price reduction shall be final and binding.

#### 5) **LEGAL JURISDICTION:**

Without prejudice Civil court of Chatrapur, Dist-Ganjam (Orissa-761020) shall have jur is diction to deal with or to decide any legal issue or dispute whatsoever arising out of this contract.

### 6) **CANCELLATION:**

IREL reserves the right to cancel the Purchase Order or any part thereof and shall be ent

ailed to rescind the contract wholly or in part in a written notice to you if;

- a. You fail to comply with the terms of the purchase order.
- b. You fail to convey written acceptance of the Order within 10 days of receipt at your e
- c. You fail to deliver goods on time and / or to replace the rejected goods promptly.
- d. You become bankrupt or go into liquidation.
- e. You make a general assignment for the benefit or creditors and a receiver is appointe d for any of the property owned by you fail.

### 7) RISK PURCHASE CLAUSE:

After award of the contract, if the tenderer fails to execute the supply as per tender or a t any time repudiates the order, IREL(India)Limited have the right to forfeit the EMD and invoke the security deposit and execute the order from other agencies at the risk and co st of the tenderer. The cost difference between the alternative arrangements and total c ontract value will be recovered from the tenderer along with other incidental charges. In case of execution of order through alternative sources and if price is lower, no benefit on this account will be passed on to the tenderer.

If a firm quotes "Nil" charges/consideration, the bid shall be treated as unresponsive and should not be considered for comparative statement.

# 8) **Arbitration:**

All questions dispute and difference whatsoever arising between the parties out of t he t erms and conditions of the contract whether during the progress of the contract or after completion or abandonment there off at the request of the aggrieved parties in writing s hall be referred to the sole arbitration of the person appointed by chairman & Managing Director, IREL. The Provisions of the Arbitration and conciliation Act 1996 as amended fr om time to time shall apply to the arbitration proceedings. The Place of Arbitration shall be OSCOM Unit, IREL where the contract has been executed.

Past Performance (Same as per page No. 4/10, Point no. 8): The Bidder or its OEM {themselves or th rough re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organizati on / PSU / Public Listed Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

**Similar Supply Definition:** Supply of any grade coal.

Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is

duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
