- 1. - **1.0** Bidders have to upload the following along with the Bid
 - (i) Documents towards pre qualification of tender failing which offer shall no t be accepted.
 - (ii) Copy of GST, PAN, MSME Registration

 - (iv) Undertaking provided in tender, duly filled and signed
 - (v) Contact details with e-mail, Phone no. etc.

2.0 Earnest Money Deposit (EMD)

- 2.1 Rs.20,000/- (Rupees Twenty thousand only)
- 2.2 Tenderer shall remit EMD through RTGS/ NEFT in favour of M/s IREL (India) Limited, Manaval akurichi.
- 2.3 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail sh ould contain full postal address of the Tenderer, Tender No. for which EMD & TDC were paid, payment details including amount, and UTR No. and bank details from which payment was d one. - 2.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.

- 2.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 2.6 The EMD is liable to be forfeited if:
 - i. The tenderer changes the terms and conditions or prices or withdraw his quotation sub sequent to the date of opening.
 - ii. The tenderer fails to accept the order when placed or fails to commence supplies/work s after accepting the order.
 - iii. In case bidder submits false/fabricated documents.
 - iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 2.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. MSME /SSI units are exempted from payment of **EMD/ TDC** provided they submit valid MSME/ NSIC certificate along with commercial bid and to ensure that certificate pertain s to the class of item/works for which floated.

3.0 SECURITY DEPOSIT (SD),

- 3.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) to wards satisfactory completion of the order/works as under:
 - a. For works contract valued more than Rs.2 lakhs.
 - b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days aft er notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including war ranty obligations/ defect liability period (DLP).

- 3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commerc ial bank' or 'Bank Guarantee issued/ confirmed from any Scheduled Commercial Banks in Ind ia' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the ten der inviting authority as called for in tender.
- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalised Banks / Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 3.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guarantee, fresh Bank Guarantee in the prescribed format or demand draft/ bankers cheque is to be submitted towards SD.
- 3.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply/ work order.

4.0 Period of contract:

Period of contract shall be one year from the date of issue of work order.

The IREL (India) Limited reserves the right to increase / decrease the ordered quantity by up to [25] percent at any time, till final delivery date (or the extended delivery date of the contr act), by giving reasonable notice even though the quantity ordered initially has been supplie d in full before the last date of the delivery period (or the extended delivery period)

5.0 Payment Terms:

- a) 100% payment shall be made after satisfactory completion of the individual item of work s on monthly basis, against production of your bill, duly certified by Engineer in-charge. In come tax and Work contract tax will be deducted at source at the rates as applicable as p er Rules / Act.
- b) GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGST/SGST Act 2017, S

ection 20 of the IGST Act. 2017 and Section 21 of the UTGST Act. 2017.

6.0 Penalty:

In case of any breakdown of Air conditioners breakdown intimation will be given to tenderer t hrough phone OR Email OR SMS. If tenderer fails to attend the breakdown job of critical installations within 48 hours of intimation and non – critical installations within 72 hours a penalt y of Rs. 350/- per day will be imposed on the tenderer from the date of intimation.

7.0 LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s)specified in the CONTRACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten per cent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of d elay/breach on the part of the Service Provider and the said amount will be payable on dema nd without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be final and binding.

- **8.0** In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall govern.
- **9.0** In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.
- 10.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.
