- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers

offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. 6. XII) Special Conditions Of Contract

1.0 GENERAL

The special conditions of the contract shall be read in conjunction with the General Conditions of the contract, Specifications or any other supplementary documents detailing the work. Providing that where any provision of the General Conditions of Contract is repugnant to or at variance unless a different intention appears, the provision of the Special Conditions of Contract shall to the extent of such repugnance or variation prevail.

2.0 Regulations, Acts, Standards & Codes to be followed:

The design, manufacture and testing of the equipment covered in this specification shall comply with the a ppropriate standards amended upto date. Unless otherwise specified, Indian Standards shall be followed. In case where suitable Indian Standards are not available, generally accepted codes and practices as mutually agreed upon shall be adopted. The equipments shall comply with the statutory requirements of Govt. of India. The equipment and installation shall conform to the provision of statutory and other regulations in force such Indian Electricity Act etc. The successful bidder shall provide the necessary support like drawings, data etc as required by the statutory authorities. In cases where the offer deviates from the specified standards, the successful bidder shall indicate clearly in his offer the standards proposed to be adopted by him and the details thereof.

3. Tender Rates:

- **a.**The rates quoted in the price schedule shall be firm throughout the period of Contract including extensio n of time, If any. The unit rates quoted in the Bill of quantities shall be firm throughout the period of Contract including extension of time, if any.
- **b.**If the bidder submits abnormally low bid in combination with other elements of the bid which raises mate rial concern as to the capability of the bidder to perform the contract at the offered price, the bidder shall be asked to provide detailed price analysis of the bid in relation to the scope, schedule allocation of risk and responsibilities and any other requirements of the bid documents. If the bidder fails to demonstrate its cap acity to deliver the contract at the offered price, the price bid shall be considered unresponsive.

- **c.**The unit rates shall be inclusive of all taxes, levies and duties levied by Central and state governments a nd all other public and local authorities at the time of tender unless otherwise stated elsewhere. If at a late r date, due to any Govt. notification, any additional/new tax/duty is imposed, then the same shall be to the IREL (India) Limited's account and the same shall be reimbursed to successful bidder on actual basis on pr oduction of documentary evidence to be furnished by the Bidder. The base date for this purpose shall be t he due date of submission of price bid/ revised price bid, as the case may be. Any variation in the existing rates of taxes/duties shall be absorbed by the contractor. The bidder shall pay and bear all liabilities in res pect of statutory variations regarding all taxes, duties, levies etc that may be imposed beyond the contract ual completion date in case the delay is due to reasons not attributable to IREL(India) Limited.
- **d.**The unit rates stated in the Bill of Quantities shall continue to be applicable for any variation in quantities stated therein even when the actual quantities are over and above than stated in the Bill of Quantities.
- e. The unit rates in the Bill of Quantities shall also include cost of the following:
- (i) Transport of material, personnel, etc. to site at the start of the work and their withdrawal on completion of work.
- (ii) Storage of materials at site and hoisting and lowering to all Levels.
- (iii) Supplying, transporting to site, unloading, protecting and installing materials in accordance with the s pecifications.
- (iv) Accommodation of the contractor's staff and labour.
- (v) Insurance of materials at the site, labour and the work as directed by the Engineer-in-charge.
- (vi) Protection of all equipment and materials, etc.;
- (vii) Necessary care and precaution against damage to equipment including that supplied by the purchase r
- (viii) All wastages.
- (ix) Workmen compensation policy
- (x) Minimum wages to workmen, retrenchment compensation, Notice pay, gratuity or bonus as applicable, PF contribution of all laborers engaged for the work.
- (xi) Medical fitness certificate for all workmen from a doctor with minimum qualification of MBBS.
- (xii) Police verification certificate from local police station for all workmen engaged for the work
- (xiii) Providing basic personal protection equipments such as safety helmets, safety shoes etc. to all work men engaged for the work.

Besides above all other terms and conditions, all statutory compliances as mentioned in this tender having financial implications shall have to be considered while quoting unit rates in the Bill of Quantities

As may be required to carry out inspection in presence of purchaser/purchaser's representative before dispatch. The necessary certificate is to be furnished by the party at the time of inspection by the purchaser.

To establish performance as per the performance guarantee clause as well as to stand warranty as per wa rrantee clause mentioned below.

4.0 DURATION OF THE CONTRACT:

The entire works shall be completed within 07 months from the date of acceptance of the contract or work order by the executing firm.

4.1 TIME PERIOD OF COMPLETION

The executing firm shall visit the site within 15 days of acceptance of the contract.

The executing firm shall submit the drawings-SLDs for both the Capacitor Panels for approval within 21 day

s of site visit.

The supply of the items shall be completed within 05 months from the date of final drawing approval.

5.0 LIQUIDATED DAMAGES FOR DELAY IN EXECUTION OF CONTRACT

Party has to follow the time period of completion as mentioned at clause no. 4.1 above. Liquidated Damag es (LD) shall be levied for delays attributable to the successful bidder in execution of orders. For delays attributable to the successful bidder, liquidated damages for such delay shall be levied at the rate of @ 0.5% per week or part thereof on the value of the contract subject to a maximum of 10% of the total value of the contract. The liquidated damage will be recovered from any outstanding bills or amount due to the succes sful bidder.

6.0 Terms OF PAYMENT:

- (i) 90% payment for supply part (along with payment of 100% of taxes and duties on supply part) shall be made within 30 days of receipt of material at IREL(India)Limited, OSCOM site and accepted by Engineer in Charge.

9.0 Inspection

The successful bidder shall have to give intimation beforehand i.e. 10 days in advance so that IREL(INDIA)L IMITED can depute its representative for carryingout Pre-Dispatch Inspection at the factory or works of OE M.

The Pre-Dispatch Inspection shall be carried out for both the MCC Panels at the OEM premises after which clearance shall be given for dispatch of the material.
