3. Special conditions of tender:-

- a) Bidder should ensure that all unserviceable and obsolete items shall be disposed/reused as per latest government guidelines and in environment friendly way.
- b) The bidder shall have to be registered as per e-waste rules with Ministry of Environment & Forest/Central Pollution Control Board/ State Pollution Control Board/Pollution Control Committee. Valid document on registration shall be produced along with the bid. Agencies without having above registration will not be allowed to participate in the bid.
- b) Bid shall be valid for 60 days from the date of opening of tender.
- c) The selected bidder shall fully indemnify, hold harmless and defend IREL from and against all claims, liabilities, and suits, damages etc. caused due to negligence/commission/omission of selected bidder and its agent or representative under tender and agreement pursuant to this invitation of offer or under the applicable laws of India.

- d) The contractor shall indemnify this office against any liability for compensation due to injury to his own workmen/engineer or to other persons inside the office premises while exceeding the contract and for any damage to the property.
 - e) Selected bidder hereto agrees that the courts and tribunals at Mumbai shall have exclusive jurisdiction to settle any or all disputes which may arise out of or in connection with this tender. All disputes arising out of this tender or any other agreement pursuant to this tender shall be decided in accordance with the laws of India.
 - f) Submission of wrong/fraudulent information/quotation may lead to disqualification of bidder and rejection of the bid.
 - g) No modification will be allowed after submission of the final bid by the bidder.
 - h) The bid documents are non transferable.
 - i) Each page of the tender document is required to be duly signed by the authorized signatory. Incomplete and undersigned quotations are liable for rejection.
 - j) IREL reserves the right to rescind, modify or amend the process of tender.

- 4. IREL shall have the full right to accept or reject or postpone the sale of any or all the items without assigning any reason.
 - 5. No item shall be taken back by IREL, once disposed to successful bidder.
 - 6. Interested parties may inspect the items and submit their sealed offer superscribed with tender number. Sealed and suitably superscripted tender bids shall be deposited in the locked tender box kept at the reception of IREL corporate office, Plot No. 1207, Veer Savarkar Marg, Prabhadevi, Mumbai 400028, on or before the due date and time indicated in NIT. Tender bids received through any other mode shall not be considered.

The tenderer shall submit tender in single sealed envelopes consisting of eligibility documents in the form of Registration Certificate declaring that the firm is **Registered Recycler/Reprocessor/Disposal of E-Waste, PAN Card, Address Proof, Annexures III to V along with financial bid (Annexure-1)**. In the absence of eligibility documents and Sale Value Deposit tender will be summarily rejected.

In case the participating bidder submits forged documents for qualifying in the tender or fails to remove the equipments within the permissible time, the bid security value deposited shall be forfeited.

The sealed envelope shall bear the tender number, tender description and due date of opening of the tender. The responsibility for ensuring that tenders are delivered in time would rest with the bidder. IREL shall not be responsible if the bids are delivered elsewhere. Any bid received after the prescribed deadline for submission of bids, shall be rejected. Conditional bids shall be summarily rejected.

If envelope is not sealed and/or superscribed as mentioned above, IREL may not accept the bid.

7. Sealed quotations of bidders will be opened by tender opening committee of IREL. The deposition of offered amount shall be verified and after confirmation, the successful bidder shall be informed and he shall remove the items from IREL godown within three working days. All costs and means (vehicle, labour etc.) required to remove the items shall be borne by the successful bidder.
