- 3. Special conditions of contract:
  - a) Bidder should ensure that all items shall be disposed as per latest government guidelines.
  - b) Bid shall be valid for 60 days from the date of opening of tender.
  - c) The selected bidder shall fully indemnify, hold harmless and defend IREL from and against all claims, liabilities, and suits, damages etc. caused due to negligence/commission/omission of selected bidder and its agent or representative under tender and agreement pursuant to this invitation of offer or under the applicable laws of India.
  - d) Selected bidder hereto agrees that the courts and tribunals at Mumbai shall have exclusive jurisdiction to settle any or all disputes which may arise out of or in connection with this tender. All disputes arising out of this tender or any other agreement pursuant to this tender shall be decided in accordance with the laws of India.

- 4. Mode of payment:

The successful bidder shall deposit 100% amount of offered sale value along with the bid submitted in the form of Demand Draft in favour of IREL (India) Limited, payable at Mumbai or NEFT.

The selected bidder shall remove the equipments with seven working days after receiving the dispatched/removal order. All costs and means required to remove the equipments from IREL shall be borne by the bidder (vehicle, labour etc.).

- 5. In case the participating bidder submits forged documents for qualifying in the tender, or fails to remove the equipments within the permissible time, the sale value deposited shall be forfeited.
- The sale value deposited in the form of submitted instrument i.e., demand draft/bankers cheque/NEFT etc. of unsuccessful tenderer shall be refunded / released within 15 days of issue of sale order to the successful bidder. No interest shall be paid on sale value deposited in case of any delay caused due to any reason whatsoever.

- 8. No item shall be taken back by IREL, once disposed to successful bidder.

- 3. Filled, Signed & stamped copy of Annexure III, IV & V
- 4. Valid payment instrument of the offered sale value in the form of DD/Banker's Cheque/NEFT Transaction Details. Any tender received without confirmed and valid payment instrument shall be summarily rejected.

The sealed envelope shall bear the tender number, tender description and due date of opening of the tender. Any bid received after the prescribed deadline for submission of bids, shall be rejected.
