## ***Section 1 – IREL Profile***

IREL (India) Limited (the “IREL”), a Mini-Ratna Category-I company, is a public sector enterprise of the Government of India under the administrative control of the Department of Atomic Energy. The company is engaged in mining and separation of beach sand minerals and produces different rare earth compounds. The operating Units of the company are located at Chavara, Kerala; Manavalakurichi, Tamil Nadu; Chatrapur, Odisha; Aluva, Kerala; Bhopal, Madhya Pradesh; Visakhapatnam, Andhra Pradesh. The Corporate Office is located at Mumbai.

IREL invites Tenders from well-established and reputed Life Insurance Companies holding valid IRDAI License as on date of the date of submission of Tender for procuring Life Insurance business in India.

### **Technical Bid**

IREL has adopted a 2 Part (2 Envelope) bidding process (collectively referred to as the “**Bidding Process**”) for selection of the Bidder for obtaining Group Term Life Policy for its employees. Comprising of the following:

#### **1. Part-I (Technical Bid)**

#### **2. Part-II (Financial Bid)**

The Bids are to be submitted online in two parts as above for **Procuring Group Term Life Policy for IREL (India) Limited**. The prospective bidders are advised to peruse the entire Request for Proposal document (RFP) for compliance in all respects to participate in the online bidding process or before, **27<sup>th</sup> June 2025**.

#### **Technical Bid:**

The Bidders who qualify as per the following criteria are only eligible for participating in further stage of the Bidding Process. Bidders who meet these criteria and submit supporting documents as detailed shall only be accepted. ### ***Section 5 – Special Conditions forming part of the Policy***

- a) IREL shall purchase the Group Term Life Insurance policy from the selected bidder for a period of one year for the sum insured, in the event of any kind of death including but not limited to as natural death, accidental death, suicidal death, death due to any illness, death due to pre-existing illness including critical illness etc.
- b) Please note that the IREL reserves the right to reject one or all of the quotations received in this connection without assigning any reason.
- c) Nomination details will only be shared at the time of claim and not at the placement.
- d) Selected Bidder will have to provide individual premium for each Individual; this is applicable for Endorsement as well.
- e) Free Cover Limit for all individual staff members covered under the policy would be sum insured asked for.
- f) Since IREL is the insured, the entire claim amount needs to be paid to IREL (India) Limited

### ***Frame work of the Proposed policy***

- Group Term Life Insurance Policy purchased by the IREL from the selected bidder will cover its **700** employees
- The information of new entrants and those leaving will be reported to the Insurance company on or before the 15<sup>th</sup> of the following month of the date of entry/exit. All such new entrants would be deemed to be covered till such time the information has been actually sent to the Insurance Company.
- The minimum and maximum age of the customers will be 18 years and 60 years respectively.
- Death due to all causes
- World-wide 24 x 7 coverage
- Suicide or attempted suicide exclusion waiver for existing employees & new employees
- Waiting period of any nature to be waived off.
- Actively at work clause waiver for existing employees & new employees
- Payment of claim should be settled for all kinds of deaths, within 30 days from the date of submission of claim.
- The selected bidder should release the payment of claim to the Master Policy holder or dependent of deceased personnel through the IREL / account of the nominee / dependent of the deceased employee on submission of attested copy of death certificate and claim form.
- **Bidders to note that previous year FCL was Rs 75 lakhs, there are no contractual Third-party employees in the group, there are no Expats in the group, no members are exceeding 10 times of CTC and there are no high-risk members in the group.**
- **The insurance shall be managed directly by us, and as such No Brokerage shall be added on the premium.**

#### **Other Conditions:**

- Midterm revision of sum insured due to promotion of an employee, on payment of requisite premium (60 days intimation period)
- Midterm additions of employee, on payment of requisite premium (60 days intimation period)
- Midterm termination of employees with pro-rate premium refund (60 days intimation period) –

- except for death cases
- No mid-term cancellation clause
- **The Financial bid being submitted must not include any brokerage payable as no insurance intermediary has been appointed by us.**
