1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. If the bidder itself is MSE OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover, shall upload the supporting documents to prove his eligibility for exemption.
2. If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Bidder Turnover" as defined above subject to their meeting of quality and technical specifications. If the bidder is DPIIT Registered OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. The bidder seeking exemption from Turnover shall upload the supporting documents to prove his eligibility for exemption.
3. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
4. Preference to Make In India products (For bids < 200 Crore):Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail the

Purchase preference, the bidder must upload a certificate from the OEM regarding the percentage of the local content and the details of locations at which the local value addition is made along with their bid, failing which no purchase preference shall be granted. In case the bid value is more than Rs 10 Crore, the declaration relating to percentage of local content shall be certified by the statutory auditor or cost auditor, if the OEM is a company and by a practicing cost accountant or a chartered accountant for OEMs other than companies as per the Public Procurement (preference to Make-in -India) order 2017 dated 04.06.2020. Only Class-I and Class-II Local suppliers as per MII order dated 4.6.2020 will be eligible to bid. Non - Local suppliers as per MII order dated 04.06.2020 are not eligible to participate. However, eligible micro and small enterprises will be allowed to participate .The buyers are advised to refer the OM No.F.1/4/2021-PPD dated 18.05.2023.

5. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 [OM No.1 4 2021 PPD dated 18.05.2023](#) for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.

### 1. Buyer Added Bid Specific ATC

#### **I. PRE-QUALIFICATION CRITERIA:**

- 1) Bidders should be an oil company registered in India and have its own refinery operating with in India. ( or) should be an oil PSU.
- 2) Public sector undertakings, state government undertakings, may be exempted from payment of EMD and SD at the sole discretion of IREL (India) Limited.
- 3) Oil PSU's who are regular supplier to IREL (BPCL, IOCL, HPCL) are exempted from submission of Pre-Qualification documents.
- 4) Party should upload deviation if any.

#### **II) Scope of contract:**

Supply of Furnace oil conforming to IS 1593:2018 at OSCOM unit of IREL (India) Ltd in a staggered manner

#### **III) Period of contract:**

2 months from the date of commencement of the first consignment or exhaustion of quantity or contract value whichever occurs first. IREL reserves the right to extend the period of contract suitably with mutual consent of supplier, in the event the contracted quantity or value remains unfinished even on expiry of contract period.

First consignment to be made within 15 days of placing of order or as per instruction of IREL.

IREL also reserves the right to terminate the contract prior to the proposed 2 months period/full consumption of the indicated quantity in view of reasons like switching to alternate fuels, etc.

#### **IV) Quantity**

The tendered quantity is 810 MT tentatively and not guaranteed

#### **V) Supply schedule**

Time is the essence of contract.

Delivery shall be on staggered delivery basis as per delivery schedule/intimation from IREL Efforts shall be taken to see that the delivery is done at our stores before 2.00 PM.

#### **VI) Method of delivery /Intimation regarding**

The furnace oil is to be delivered by road tankers

The furnace oil is to be delivered promptly on intimation from our end by E-mail/fax/mobile SMS failing which appropriate LD shall be deducted if it leads to production loss.

#### **VII) Price basis**

The offer should be on FOR destination (delivered basis) only as per price schedule. The validity of tender offer shall be 90 days from the due date of submission of offer or as per the clauses governing validity of the tender, unless otherwise spelt separately.

There shall not be any reduction in the offered discount during the period of contract. Bidder has to furnish

ish the escalation / de-escalation formula based on which the delivery assistance charges shall be increased or decreased. The time schedule of revision shall also be mentioned.

Order shall be placed on quoted rates. However, for deliveries, rates prevailing at time of supply will be applicable. Any reduction in rate will be passed on to IREL.

**VIII) Payment terms:**

Advance payment on recommendation from IREL Stores Department against Proforma invoice through RTGS.

**IX) Mode of Payment:**

Bidders are requested to furnish the bank details to enable digital mode of payment.

The payment shall be released after deducting the following:

- (a) Compensation recoverable if any.
- (b) LD recoverable, if any
- (c) Recoveries on account of contracture's facilities and services, if any.
- (d) Deduction, if any, towards re-couplement of any amounts forfeited, adjusted, deducted out of security deposit.
- (e) All Statutory deduction, if any, as per rules.
- (f) Deduction as per IT Act, 1961, if any.
- (g) Any other deduction related to this contract.

**X)Liquidated Damages (LD):**

If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed delivery period(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, unless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period, until actual delivery or performance, as per re-estimated damages not exceeding 5% of the total contract value without any controversy/dispute of any sort whatsoever. However, in case of inordinate delay maximum deduction shall be 10% of the total contract value.

Note: Inexcusable delays of more than one-fourth (25%) of the completion period specified in the contract shall be treated as inordinate delay(s).

XI) Purchase Preference is given as specified in bid. Bidders are advised to take care to claim for the PPP/MII purchase preference feature by uploading the MSE document once again in PPP/MII purchase preference part while participating in the GeM bid.

XII) Offers from vendors defaulted to IREL (India) Limited, OSCOM during last one year will not be considered.
