- 1. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3-year-old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.
- 3. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 4. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 5. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

3. Buyer Added Bid Specific ATC

Prequalification criteria (PQ) of the Tender.

PQ1: Prior Experience Criteria:

The bidder should be an experienced service provider of excavation or loading and transportation or dredging or refilling of any sand or gravel or morum or boulders.

Tender stipulation on prior experience:

To meet the above experience criteria,

The bidder should have successfully completed similar service contracts during the last seven years ending 31.03.2025 meeting any of the following:

- a) Three similar completed service contracts costing not less than Rs.1,74,16,800/- (40 % of the estimated value including GST) or
- b) Two similar completed service contracts costing not less than Rs.2,17,71,000/-(50 % of estimated value including GST) or
- c) One similar completed service contracts costing not less than Rs.3,48,33,600/-(80 % of the estimated value including GST)

Documents to be submitted;

For non-governmental service contracts: Copy of work orders and its work completion certificates along w ith TDS- Form 16/ FORM No.26 AS / GST return to the extent of value of work experience.

<u>Definition of similar service/work contracts</u> - "Service provider of excavation or loading and transport ation or dredging or refilling of any sand or gravel or morum or boulders."

PQ-2: Prior Turnover Criteria:

The average annual turnover of the bidder for the last three consecutive financial years ending on 31st Ma rch 2024 shall be at least Rs.1,10,70,000/- (30% of estimated value excluding GST). If financial details are not submitted for any of the years, the turnover will be calculated by dividing the total turnover as per the submitted documents by three.

Documents to be submitted: Bidder shall submit financial standing through latest Income Tax return (I TR)/ Annual report containing balance sheet and statement of profit & loss account for the relevant periods

However, in case the date of constitution/ incorporation of the bidder is less than three years old, the average turnover in respect of the completed financial years after the date of constitution shall be taken in to account for this criterion.

The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annualized esti mated value of the work under consideration exceeds 4 times the average annual turnover of the precedin g 3 years. The bidder shall submit financial standing through latest Income Tax return (ITR)/ Annual report containing balance sheet and statement of profit & loss account for the relevant periods.

The bids qualifying PQ-1, PQ-2, & PQ-3 only will be considered for further processing.

Period of Contract:

The period of contract shall be 90 days from the date of issue of work order or completion of the estimated quantity 60,000 MT, whichever is earlier. Since the work is a part of Disaster Managem ent activity, the successful tenderer shall commence the work with 48 hours of issuing work orde r or any other time extended by IREL. If there is a delay in start the work beyond 48 hours, penal ty will be levied @ of Rs.5,000/- per day and company will make alternate arrangement at the ris k & cost of the successful tenderer.

Payment to the contractor:

Payment shall be made on monthly basis within 30 days of the submission of the bill and after the ac tual work done is verified & certified by Engineer in Charge. All running bills shall be submitted al ong with the hindrance register duly signed by the contractor & Engineer-In Charge maintained f or the purpose.

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.

- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.

- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace.
