Two similar completed works each costing not less than the amount equal to Rs.8.18 Lakhs.

OR

Three similar completed works each costing not less than the amount equal to Rs.6.54 Lakhs.

Definition of Similar work(s): Executed Supply of Pressure Transmitter.
