- A.. "Empanelled bidders as per the EOI bearing reference IREL/CHAVARA/EOI/18-19/01 dated 26.02.2019 and IREL/CHAVARA/EOI/20-21/02 dated 29.09.2020, for empanelment of bidders for "Mineral sand collection, up gradation of mineral sand (at certain point) and transporta tion of mineral sand /upgraded mineral sand to nearby sites/IREL Chavara, providing HEMM, tippers on hourly chargeable basis (MSP,VT and any other sites if required) and tailing sand refilling at various excavated sites.
- B. . The threshold value mentioned in the letter issued by IREL against the above referred Expression Of Interest shall be equal or above the estimate (excluding GST) for this work Estimate value Excluding GST Rs.1,22,72,000/-

2. Penalty

- i) The contractor shall transport monthly targeted quantity of 8500 tonnes of tailssand from t he VT mining site tails yard to the excavated pits/mined out areas of Pandarathuruthu. If the contractor fails to transport the monthly targeted quantity of 8500 tonnes due to reason attri butable to them, penalty will be levied for every tons of the shortfall quantity at the rate of 5 % of quoted rate. However, the total deductions in lieu of LD and penalties if any imposed shall not exceed 10% of contract value.
 - ii) The tails sand transported in a day shall be levelled on the same day itself by using contractor's wheel loader. If it is not done so, it shall affect next day's transportation. In c ase contractor is unable to do so and it is required urgently for levelling, an amount of Rs.1500/-per hour will be deducted from the contractor's bill for engagement of company hired loader.

3. PAYMENT OF THE CONTRACTOR

Payment to contractor will be made on monthly basis within one month after submission of duly filled bills and after the work done is certified by Engineer -In Charge on the basis of the log book maintained for the purpose.

All payments will be subjected to deduction of income tax at source at the prevailing rate of t ax as per the income tax act/rule

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.

- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
