1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Bidder financial standing: The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

Pre-Qualification criteria:

Empanelled bidders eligible as per the EOI bearing reference IREL/CHAVARA/EOI/18-1901 dated 26.02.201 9 and IREL/CHAVARA/EOI/20-21/02 dated 29.09.2020 , for empanelment of bidders for "Mineral sand collection, upgradation of mineral sand (at certain point) and transportation of mineral sand /upgraded mineral s and to nearby sites/IREL Chavara, providing HEMM, tippers on hourly chargeable basis(MSP,VT and any ot her site s if required) and tailing sand refilling at various excavated sites

>> Bidders are required to peruse the Tender Document including PQ criteria , Scope of work, SCOC etc.,i n full and thoroughly before submitting their bids

>>Scope of work:

Manual collection of mineral sand from beach front and other areas & Loading of TOYO / dredger output by engaging VT/Ponmana forum members, Transportation of mineral sand from VT/Ponmana mining area and unloading near to spiral plant at VT mining site.

>>Quantity:

Total quantity is 60,000 t

>> Period of contract:

The period of contract will be Six (06) months from the date of commencement of the work. The contractor should expeditiously settle all the local issues related to the transportation work at his own risk and cost

The work should be started within 7 days of the receipt of the work order or as directed by Engineer-in-Cha rge. If there is a delay in start the work beyond 7 days, penalty will be levied at a rate of Rs.5000/- per day

>>Penalty:

As per Clause No.14.4.2 and 14.7 and others as per tender

>> Payment to contractor will be made on monthly pro-rata basis within one month after submission of bil Is and after the work done is certified by Engineer -In Charge

Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. Any clause(s) incorporated by the Buyer regarding following shall be treated as null and void and would not be considered as part of bid:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without

- specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
