- IREL (India) Limited is a Mini Ratna, Category-1 CPSE under the administrative control of Dept. of Atomic

Energy (DAE) with the mandate of producing Rare Earths and other strategic compounds for National Security. For ensuring raw material security for its strategic operations and to cater the feed stock requirement s of large number of industries in the country including MSME's, IREL propose to carry out mining in its lease hold areas at Ayanivelikulangara village through competent contractor. The work involves site preparation, fencing of the proposed mining area, excavation and collection, loading and transportation of 80,00 tons of mineralsand from the mining lease area at Ayanivelikulangara Village to IREL, Chavara Plant. The work also involves transportation of 80,000 tons of tails sand from IREL, Chavara plant to Ayanivelikulangara Village for refilling the mined-out area to its original topography etc., as per scope of work of the tender document

>>Quantity:

- -Total quantity of mineral sand proposed to be excavated, stacked & heaped at mining site, loaded and transported to the IREL, Chavara plant is 80,000 tons **on zero moisture basis**

- 8. Seeking sample with bid or approval of samples during bid evaluation process.
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is governed by the <u>General Terms and Conditions/सामान्य नियम और शर्त</u>, conditions stipulated in Bid and <u>Service Level Agreement</u> specific to this Service as provided in the Marketplace. However in case if any condition specified in General Terms and Conditions/सामान्य नियम और शर्ते is contradicted by the conditions stipulated in Service Level Agreement, then it will over ride the conditions in the General Terms and Conditions.
