1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

PRE QUALIFICATION CRITERIA

The tenderer should submit the following towards Pre- Qualification Criteria.

- 1. Bidder shall be a supplier / manufacturer of rubber / silicone products for the past 7 years from the date of publication of tender. Copies of purchase order and performance certificate / Tax Invoice completion certificate are to be enclosed.
- 2. The average annual financial turnover of "The bidder" during last three years, ending 31 st March 2022 sho uld be Rs.30,000/-. Bidder has to submit copy of balance sheet / profit & loss account statement / turno ver duly certified by Statutory Auditor / IT Return.

Note:

- 1. In the absence of receipt of Pre-Qualification Criteria, the offer will not be considered under any ci rcumstances.
- 2. Pre-Qualification Criteria can be relaxed for MSEs and Start up companies subject to meeting qual ity and technical specification.
- 3. Offers from vendors defaulted to IREL (India) Limited, Manavalakurichi during last one year will n ot be considered.

Other Terms & Conditions

- 1. The Party has to upload the following along with the Bid
 - (i) Documents towards pre qualification of tender failing which offer shall not be accepted.
 - (ii) Copy of GST, PAN, MSME Registration
 - (iii) Undertaking provided in tender, duly filled and signed
 - (iv) Contact details with e-mail, Phone no. etc.
- 2. The rate quoted shall be FOR IREL (India) Limited, Manavalakurichi. The items have to be supplied strictly as per the technical specification within the delivery period mentioned in the tender.
- 3. Delivery Period

For item no. 1. supply schedule shall be 300 nos. every month for 5 months.

For item nos. 2 to 5 supply shall be completed within 45 days from the date of issue of Purchase Order.

4. SECURITY DEPOSIT (SD),

4.1. Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards

satisfactory completion of the order/works as under:

- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (DLP).

- 4.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bond s' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guarantee issued/ confirmed from any Scheduled Commercial Banks in India' or online paym ent to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 4.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalised Banks/ Schedule d

Commercial Banks (other than Cooperative Banks) only acceptable.

4.4. EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitt ed in the form of Bank

Guarantee, fresh Bank Guarantee in the prescribed format or demand draft/ bankers cheque is to be

submitted towards SD.

4.5. The SD shall not bear any interest and is liable to be forfeited for unsatisfac tory completion or on

abandonment of the supply/ work order.

5. Payment terms

Our standard payment term is 100% payment within 30 days from the date of receipt and acceptance of materials along with all relevant documents" **NO advance payment shall be made under any circumstances**. Interest @12% shall be considered for evaluation of bids in case of supplier(s)/ contractor(s) requesting for payment earlier than our stipulated terms.

GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGST/SGST Act 2017, Section 20 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.

6. Liquidated Damages

Subject to Article -32, if the SELLER fails to deliver any or all of the GOODS or performance the services within the time period (s) specified in the CONTRACT, the PURCHASER shall, without prejudice to his ot her remedies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delivered late, for each we ek or part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of the value of delaye d goods. The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value shall be reduced proport ionately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the PURCHASER may deduct the amount so payable by SELLER, from any amount falling due to the SELLER or by recovery against the Performance Guarantee. Both seller and PURCHASER agree that the above percentages of price reduction are genuine preestimates of the loss/damage which the PURCHASER would have suffered on account of delay/breach on the part of the SELLER and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the PURCHASER in the matter of applicability of price reduction shall be final and binding.

7. In case of any discrepancy between GeM GTC and Buyer ATC, terms stipulated under buyer ATC shall govern.
