- 1. The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated above in the bid document. - 2. Years of Past Experience required: The bidder must have experience for number of years as indicated above in bid document (ending month of March prior to the bid opening) of providing similar type of services to any Central / State Govt Organization / PSU. Copies of relevant contracts / orders to be uploaded along with bid in support of having provided services during each of the Financial year.
- 3. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. #### 1. Generic

OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

## 2. Generic

**Bidder financial standing:** The bidder should not be under liquidation, court receivership or similar proceedings, should not be bankrupt. Bidder to upload undertaking to this effect with bid.

# **PQ1. Prior Experience Criteria:**

The bidder shall be an experienced service provider of desilting / dredging of harbour, ports or an y legally designated water body using diesel operated dredgers having a minimum capacity of 100 tph (tons per/hour) or water discharge capacity of 1000 m<sup>3</sup>/hour or more for the desilting of s

If financial details are not submitted for any of the years, the turnove r will be calculated by dividing the total turnover as per the submitted documents by three.

**PQ- 4 : Concurrent commitment:** In order to assess the Bidder Capability and Spare Capacity t o perform the assignment of execution of the tendered work, the bidder shall disclose all works being executed by them as per the format given below.

The bidder will be disqualified if the annualized concurrent commitments of the bidder plus annual ized estimated value of the work under consideration exceeds 4 times the average annual turnove r of the preceding 3 years. The bidder shall submit financial standing through latest Income Tax re turn (ITR)/ Annual report containing balance sheet and statement of profit & loss account for the re levant periods.

The bids qualifying PQ-1, PQ-2, PQ-3, & PQ-4 only will be considered for further processing.

**Period of contract:** Period of contract is for 6 (six) months from starting of work as per the order by the contractor to dredge out 60,000t of sand.

Payment to the contractor/ schedule of payment: Payment shall be made on monthly basis within 30 days of the submission of the bill and after the actual work done is verified & certified by Engineer in Charge. All running bills shall be submitted along with the details of breakdowns in a register duly signed by the contractor & Engineer-In Charge maintained for the purpose.

All other conditions in the tender document shall be applicable to this contract.

## Disclaimer/अस्वीकरण

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
