1. TECHNICAL COMPETENCY

The bidder should be an IRDA approved agency or an authorized dealer of such firm.

Documents against the above criteria complete in all respect must be uploaded.

Failure to compliance of above shall make the bid incomplete and such it shall be rejected.

2. Note: As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Procurement of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid.
