Bidders are bound to accept the orders accordingly.

### 5. SECURITY DEPOSIT (SD),

5.1. Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards

satisfactory completion of the order/works as under:

- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notif ication of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of co mpletion of all contractual obligations of the supplier/ contractor, including warranty obligations/ de fect liability period (DLP).
