If the bidder wants to avail the Purchase preference, the bidder must be the manufacturer of the offered product in case of bid for supply of goods. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service. If L-1 is not an MSE and MSE Seller (s) has/have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such Seller shall be given opportunity to match L-1 price and contract will be awarded for 25%(selected by Buyer) percentage of total QUANTITY. #### 2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of EFT Mandate duly certified by Bank.

#### 3. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers

can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

#### 4. **Generic**

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

- i) The Seller fails to comply with any material term of the Contract.
- ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.
- iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.
- iv) The Seller becomes bankrupt or goes into liquidation.
- v) The Seller makes a general assignment for the benefit of creditors.
- vi) A receiver is appointed for any substantial property owned by the Seller.
- vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

Copies of relevant Purchase Order copy for supply of the order to be submitted along with tax invoice or e-way bill or proof of satisfactory performance report from the receiving party or proof of payment received from the party against that order.
- b) Bidder should have valid authorization certificate from OEM for dealer / distributorship.
- c) Bidder should have valid storage license.
- d) **AVAILABILITY OF OFFICE OF SERVICE PROVIDER** : An office of the Service Provider must be located in the state of Consignee.(Odisha State)

**NB:** For MSE bidders & start-ups as recognised by DPIIT (Department for Promotion of Industry and Internal Trade), Past experience is relaxed. However, bidders have to establish their technical competency by submitting supporting documents towards successful execution of similar work for **any value**, failure to which the offer will not be considered for evaluation.
