OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

## 2. Buyer Added Bid Specific ATC

#### **PRE QUALIFICATION CRITERIA**

The bidder should submit the following towards Pre-qualification Criteria:

- 4.5. Offers without EMD or valid EMD exemption certificate shall not be considered.
- 4.6. The EMD is liable to be forfeited if:
  - i. The tenderer changes the terms and conditions or prices or withdraw his quotation subs equent to the date of opening.
  - ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
  - iii. In case bidder submits false/fabricated documents.

## 5. Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit **@5% of the contract value** in the fo rm of RTGS/NEFT/ BG within 21 days of receipt of our PO as security for satisfactory completio n of the order. The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply order. The EMD can be adjusted towards Securit y Deposit. However, if EMD is submitted in the form of BG, fresh BG is to be submitted toward s SD in the prescribed format as per tender. If the Supplier fails to provide the security deposi t within the period specified, such failure shall constitute a breach of the Contract and IREL sh all be entitled to make other arrangements for the repurchase of the stores contracted for at t he risk and expense of the supplier and/or to recover from the supplier the damages arising fr om such cancellation.

#### 6. Payment terms

Our standard payment term is 100% payment within 30 days from the date of receipt and ac ceptance of materials along with all relevant documents" **NO advance payment shall be m ade under any circumstances**. Interest @ 12% shall be considered for evaluation of bids in case of supplier(s)/contractor(s) requesting for payment earlier than our stipulated terms. GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGST/SGST Act 201 7, Section 20 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.

## 7. Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or performance the services within the time period (s) specified in the CONTRACT, the PURCHASER shall, without p rejudice to his other remedies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

#### Deductions shall apply as per following formula

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of th e value of delayed goods. The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value shall be reduced proportionately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the PURCHASER ma

y deduct the amount so payable by SELLER, from any amount falling due to the SELLER or by r ecovery against the Performance Guarantee. Both seller and PURCHASER agree that the above percentages of price reduction are genuine preestimates of the loss/damage which the PURCH ASER would have suffered on account of delay/breach on the part of the SELLER and the said a mount will be payable on demand without there being any proof of the actual loss/or damage c aused by such breach/delay. A decision of the PURCHASER in the matter of applicability of pric e reduction shall be final and binding.

In case of any discrepancy between GeM GTC and Buyer ATC, terms stipulated under buyer AT C shall govern.
