If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. The tenderer should submit the following towards Pre- Qualification Criteria:

- 1) The tenderer shall submit copies of documentary proof of execution of similar works during I ast 7 years ending 31st May 2024 and the same should be either of the following:

2.0 Earnest Money Deposit (EMD)

- **2.4** Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- **2.5** Offers without EMD or valid EMD exemption certificate shall not be considered.
- **2.6** The EMD is liable to be forfeited if:
 - i. The tenderer changes the terms and conditions or prices or withdraw his quotation subs equent to the date of opening.
 - ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
 - iii. In case bidder submits false/fabricated documents.
 - iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 2.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and a pproval. MSME /SSI units are exempted from payment of EMD/ TDC provided they submit v alid MSME/ NSIC certificate along with commercial bid and to ensure that certificate pertains t o the class of item/works for which floated.

3.0 SECURITY DEPOSIT (SD),

- 3.1. Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) tow ards satisfactory completion of the order/works as under:
 - a. For works contract valued more than Rs.2 lakhs.
 - b. For supply & service contract valued more than Rs.5 lakhs.
 - Performance Security is to be furnished by a specified date (generally 14 (fourteen) days af ter notification of the award) and it should remain valid for a period of 60 (sixty) days beyon d the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (DLP).
- 3.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety B onds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guarantee issued/ confirmed from any Scheduled Commercial Banks in India' o r online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender in viting authority as called for in tender.
- 3.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalised Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 3.4. EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of B ank Guarantee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers ch eque is to be submitted towards SD.
- 3.5. The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply/ work order.

4.0 Payment Terms

Payment shall be made on the basis of the excavator operating hours. The contractor shall sub mit the bills on a monthly basis to the Engineer-In charge. No payment shall be claimed nor wil I any payment be made for idle hours.

All payments are subject to deduction of tax at source as applicable.

GST Law mandates Tax Deduction at Source (TDS) vide section 51 of the CGST/SGST act 2017, section 20 of the IGST act 2017 and section 21 of the UTGST act 2017.

Our GSTIN 33AAACI2799F1ZL and SAC code of service is to be mentioned in the bills.

All the payment will be done only through e-payment. Hence, you have to provide your name, account no., name of the bank, and nature of account (savings/current/CC/OD), IFSC, branch code and cancelled check along with invoice.

5.0 LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s)specified in the CONTRACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling d ue to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be final and binding.

6.0 Penalty:

- a. In case the contractor fails to commence the work by mobilizing the equipment within 05 days of i ssue of work order, the contractor shall be liable to pay penalty at the hiring rate for an estimated daily average of 5 hours per day for each day's delay in commencing the work.
- b. During the contract period, in case the contractor fails to provide the Excavator for operation due to breakdown of machine or any other reasons for more than 12 hours, the contractor shall deploy an excavator of similar capacity and model, immediately within 12 hours, failing which he shall be liable to pay penalty as below:
 - For each day's delay, beyond 12 hours from the time of break down, penalty per day will be applicable at the hiring rate for the daily average operated hours in that particular month.
 - c. During the contract period, in case the contractor fails to provide the Excavator for operatio n due to absence of operator for more than 2 hours, from the 3rd hour penalty will be applic able for each hour's delay at the hiring rate.

7.0 Period of contract:

The contract will be for a period of twelve months for a quantity of 1500 hours.

- **6.0** In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall govern.
- **8.0** In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipula ted by IREL shall govern.
- 9.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.
