- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. - 5. Preference to Make In India products (For bids < 200 Crore): Preference shall be given to Class 1 local supplier as defined in public procurement (Preference to Make in India), Order 2017 as amended from time to time and its subsequent Orders/Notifications issued by concerned Nodal Ministry for specific Goods/Products. The minimum local content to qualify as a Class 1 local supplier is denoted in the bid document. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. 7. #### 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

#### **PRE QUALIFICATION CRITERIA**

# Bidder should submit the below documents towards Pre-Qualification Criteria

- 1. The tenderer should be a manufacturer or authorised dealer for supply of slurry P ump. The dealer should submit authorisation certificate from the manufacturer.
- 2. The tenderer should have supplied at least one slurry pump model 8/6 E AH with PU Lined or bigger size to beach sand minerals industries during last 7 year endin g from the date of tender. The tenderer shall submit copies of the purchase order along with performance certificate/ satisfactory completion certificate issued by b uyer.
- 3. The average annual financial turnover of the bidder during last three financial ye ars, ending 31st March 2023 should be Rs.15,67,662/-. Bidder has to submit copy of balance sheet / profit & loss account statement / turnover duly certified by Stat utory Auditor / IT Return.
- 4. Bidder shall submit the duly filled & signed technical specification questionnaire. Deviation shall be specified in the questionnaire.
- 5. Performance curve catalogue/data sheet for the impeller for quoted Slurry pumps shall be submitted along with offers.

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be considered under any circumstances.
- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Startups (as defined by Department of Industrial Policy and Promotion) as per Govern ment Circular / Guidelines subject to meeting of quality and technical Specificati on.
- 3. The offers of the bidders who have defaulted in the past in execution of the cont racts or in complying with the obligations as per the contract shall not be considered.
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from th e purview of the Procurement Policy for Micro and small Enterprises, 2 012 (as amended time to time).

#### 3.0 Delivery Period

Delivery shall be completed within 120 days from the date of issue of purchase order.

#### 4.0 Earnest Money Deposit (EMD)

- 4.2 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limit ed, Manavalakurichi.

- 4.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the tender. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 4.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 4.6 The EMD is liable to be forfeited if:
  - i. The tenderer changes the terms and conditions or prices or withdraw his qu otation subsequent to the date of opening.

- ii. The tenderer fails to accept the order when placed or fails to commence sup plies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply ord er.
- 4.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to r equest and approval. MSME /SSI units are exempted from payment of EMD/ TD C provided they submit valid MSME/ NSIC certificate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floate d.

### 5.0 Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit @5% of the contract value in the form of RTGS/NEFT/ BG within 21 days of receipt of our PO as security for satisfactory completion of the order. The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply order. The EMD can be adjusted towards Security Deposit. However, if EMD is submitted in the form of BG, fresh BG is to be submitted towards SD in the prescribed format as per tender. If the Supplier fails to provide the security deposit within the period specified, such failure shall constitute a breach of the Contract and IREL shall be entitled to make other arrangements for the repurchase of the stores contracted for at the risk and expense of the supplier and/or to recover from the supplier the damages arising from such cancellation.

### 6.0 Regulations, Acts, Standards & Codes to be followed:

The design, manufacture, supply to site and testing of the equipment covered in this specification shall comply with the appropriate standards amended up to March, 2023. Unless otherwise specified, Indian Standards shall be followed. In case where suitable Indian Standards are not available, generally accepted codes and practices as mutually agreed upon shall be adopted. The equipments shall comply with the statutory requirements of the Govt. of India. The equipment and installation shall conform to the provision of statutory and other regulations in force. The successful bidder shall provide the necessary support like drawings, data etc as required by the statutory authorities. In cases where the offer deviates from the specified standards, bidder shall indicate clearly in his of fer the standards proposed to be adopted by him and the details thereof.

#### 7.0 Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or per formance the services within the time period (s) specified in the CONTRACT, the PURCHASER shall, without prejudice to his other remedies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRA CT PRICE, including subsequent modifications.

### **Deductions shall apply as per following formula**

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores deli vered late, for each week or part thereof of delay. The total damages shall not e xceed 10 (Ten) per cent of the value of delayed goods. The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value sh all be reduced proportionately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the P URCHASER may deduct the amount so payable by SELLER, from any amount falling due to the SELLER or by recovery against the Performance Guarantee. Both s

eller and PURCHASER agree that the above percentages of price reduction are g enuine preestimates of the loss/damage which the PURCHASER would have suffe red on account of delay/breach on the part of the SELLER and the said amount w ill be payable on demand without there being any proof of the actual loss/or dam age caused by such breach/delay. A decision of the PURCHASER in the matter of applicability of price reduction shall be final and binding.

In case of any discrepancy between GeM GTC and Buyer ATC, terms stipulated u nder buyer ATC shall govern.
