If the bidder is a DPIIT registered Startup, the bidder shall be exempted from the the eligibility criteria of "Experience Criteria" as defined above subject to their meeting of quality and technical specifications. - 2. - 2. All specifications, terms & conditions specified in the "Buyer Specification Document" are applicable to this bid
