1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.

2. If the bidder is a Startup, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to their meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
3. Experience Criteria: In respect of the filter applied for experience criteria, the Bidder or its OEM {themselves or through reseller(s)} should have regularly, manufactured and supplied same or similar Category Products to any Central / State Govt Organization / PSU for number of Financial years as indicated above in the bid document before the bid opening date. Copies of relevant contracts to be submitted along with bid in support of having supplied some quantity during each of the Financial year. In case of bunch bids, the category of primary product having highest value should meet this criterion.

4. Purchase preference will be given to MSEs having valid Udyam Registration and whose credentials are validated online through Udyam Registration portal as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. In respect of bid for Services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered product or service and Buyer will decide eligibility for purchase preference based on documentary evidence submitted, while evaluating the bid. If L-1 is not an MSE and MSE Seller (s) has / have quoted price within L-1+ 15% (Selected by Buyer) of margin of purchase preference /price band defined in relevant policy, such MSE Seller shall be given opportunity to match L-1 price and contract will be awarded for 25% (selected by Buyer) percentage of total quantity. The buyers are advised to refer the OM No. F.1/4/2021-PPD dated 18.05.2023 OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if seller is validated on-line in GeM profile as well as validated and approved by Buyer after evaluation of documents submitted.

5. Past Performance: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied same or similar Category Products for 50% of bid quantity, in at least one of the last three Financial years before the bid opening date to any Central / State Govt Organization / PSU. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.

1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up

to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity by up to 25% of the contracted quantity during the currency of the contract at the contracted rates. Bidders are bound to accept the orders accordingly.

2. Buyer Added Bid Specific ATC

PRE QUALIFICATION CRITERIA

Bidder should submit the below documents towards Pre-Qualification Criteria

- 1. The Tenderer shall be an Original Equipment Manufacturer (OEM) or Authorized Dealer/Supplier of the equipment and must submit the Authorization Certificate from the Original Equipment Manufacturer.
- 2. Bidder should have executed similar supply during last seven years ending on August, 2024 NIT is req uired costing not less than ₹59,000/- along with Tax Invoice/Delivery Challan/ Completion Certificate a s a proof for execution of similar supply.

Similar Supply means "Supply of Portable High Volume Air Sampler with Electronic Flow Gauge".

3. The average annual financial turnover of the Tenderer during the financial years 2020-21, 2021-22 & 2 022-23 should be minimum of Rs.35,400/-. Bidder has to submit the copy of balance sheet and Profit & Loss account statement / Income and Expenditure Account duly certified by Statutory Auditor / IT R eturn.

Note:

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be con sidered under any circumstances.
- Relaxation in prior turnover and prior experience shall be given to MSEs / Start-ups (as defined by D epartment of Industrial Policy and Promotion) as per Government Circular / Guidelines subject to me eting of quality and technical Specification.
- **3.** The offers of the bidders who have defaulted in the past in execution of the contracts or in complyin g with the obligations as per the contract shall not be considered.
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the P rocurement Policy for Micro and small Enterprises, 2012 (as amended time to time).

Other Terms & Conditions

1.0 The Party has to upload the following along with the Bid

- (ii) Copy of GST, PAN , MSME Registration

- (iv) Undertaking provided in tender, duly filled and signed
- (v) Contact details with e-mail, Phone no. etc.
- **2.0** The rate quoted shall be FOR IREL (India) Limited, Manavalakurichi. The items have to be supplied st rictly as per the technical specification within the delivery period mentioned in the tender.

3.0 Delivery Period

Delivery shall be completed within **90 days** from the date of issue of purchase order.

4.0 Earnest Money Deposit (EMD)

- 4.1-Tenderer shall remit EMD through RTGS/NEFT infavour of M/s IREL (India) Limited, Manavalakurichi.
- 4.2—Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail should contain full postal address of the Tenderer, Tender No. for which EMD & TDC were paid, payment details in ncluding amount, and UTR No. and bank details from which payment was done. IREL's Email id is pur chase-mk@irel.co.in
- 4.3—Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the te nder. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 4.4 Offers without EMD or valid EMD exemption certificate shall not be consider ed.

4.5_The EMD is liable to be forfeited if:

- --i--The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent t o the date of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after acc epting the order.

- 4.6 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. MSME /SSI units are exempted from payment of EMD/ TDC provided they submit valid MSME/ NSI C certificate along with commercial bid and to ensure that certificate pertains to the class of item/wo rks for which floated.
- 4.7—Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the Pr ocurement Policy for Micro and small Enterprises, 2012 (as amended time to time).

5.0 Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit **@5% of the contract value** in the form of RTGS/NEFT/ BG within 21 days of receipt of our PO as security for satisfactory completion of the orde r. The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on a bandonment of the supply order. The EMD can be adjusted towards Security Deposit. However, if EM D is submitted in the form of BG, fresh BG is to be submitted towards SD in the prescribed format as per tender. If the Supplier fails to provide the security deposit within the period specified, such failure shall constitute a breach of the Contract and IREL shall be entitled to make other arrangemen ts for the repurchase of the stores contracted for at the risk and expense of the supplier and/or to rec over from the supplier the damages arising from such cancellation.

6.0 Guarantee Period

The tenderer shall provide guarantee for trouble free operation for a minimum period of one year fro m the date of successful commissioning at our site.

7.0 Performance Guarantee

Ten percent of the ordered value will be kept as Performance Guarantee for a period of one year trou ble free operation of the equipment and will be released after completion of the Guarantee period or against submission of performance Bank Guarantee of equivalent value valid 14 month from the dat e of commissioning.

8.0 Payment terms

- a) 90% within 30 days of supply, testing & commissioning of the system
- b) 10% within 365 days of completion of guarantee period.
- c) All payments are subject to deduction of tax at source as applicable.
- d) GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGST/SGST Act 2017, Section 20 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.
- e) Please mention IREL (India) Limited GST number (33AAACI2799F1ZL) and HSN/SAC code of goo ds/services in your bills.
- f) All payments shall be done only through E-payment. Hence successful bidder has to provide Co mpany name, Account number, Name of the bank, nature of account (Savings/ Current/ CC/OD), IFS Code, Branch Code along with invoice.

9.0 Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or performance the servic es within the time period (s) specified in the CONTRACT, the PURCHASER shall, without prejudice to h is other remedies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of the value of d elayed goods. The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value shall be reduced prop ortionately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the PURCHASER may dedu ct the amount so payable by SELLER, from any amount falling due to the SELLER or by recovery agai nst the Performance Guarantee. Both seller and PURCHASER agree that the above percentages of pri ce reduction are genuine preestimates of the loss/damage which the PURCHASER would have suffere d on account of delay/breach on the part of the SELLER and the said amount will be payable on dem and without there being any proof of the actual loss/or damage caused by such breach/delay. A deci sion of the PURCHASER in the matter of applicability of price reduction shall be final and binding.

In case of any discrepancy between GeM GTC and Buyer ATC, terms stipulated under buyer ATC sh all govern.

- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.

14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.
