The Bidder shall be a legal entity registered under the Indian Companies Act 2013, having completed at least 1 (one) EPC project/ composite contract (Procurement, supply, construction, erection and commissioning on lump sum turnkey basis in any mining/ mineral processing industry in India.

#### **Document required as applicable -**

Contract copy along with commissioning certificate /work completion certificate
