- 1. - 2. Note: As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Procurement of Goods 20 17, issued by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, the purcha ser may, at his discretion, ask the bidder for clarifications on the bid.
