- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. 1. Generic

OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity \div Original quantity) \times Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

- 3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying wi th the obligations as per the contract shall not be considered.

- 3.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the ten der. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-C ommercial Bid.
- 3.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 3.6 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the dat e of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 3.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. M SME /SSI units—are exempted from payment of EMD/ TDC—provided they submit valid MSME/ NSIC certific ate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.
- 4.0 Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit @5% of the contract value in the form of RTGS/NE FT/ BG within 21 days of receipt of our PO as security for satisfactory completion of the order. The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply order. The EMD can be adjusted towards Security Deposit. However, if EMD is submitted in the form of BG, fresh BG is to be submitted towards SD in the prescribed format as per tender. If the Supplier fails to provide the security deposit within the period specified, such failure shall constitute a breach of the Cont ract and IREL shall be entitled to make other arrangements for the repurchase of the stores contracted for at the risk and expense of the supplier and/or to recover from the supplier the damages arising from such cancellation.

- 5.0 Special conditions of the contract:
- Pre-delivery inspection and testing:

Supplier shall arrange for a pre-delivery inspection of the equipment at their works before dispatch. On rec eipt of intimation from the supplier about their readiness, IREL shall carryout the pre-delivery inspection at Supplier's place and conduct test work using feed samples to ensure the metallurgical performance and issue clearance for dispatch.

The party shall provide the instrument to be used for measurement of magnetic intensity on the RERMS rol I & belt surface which shall have valid calibration certificate traceable to NABL/ NPL standards.

However the final inspection on receipt of the equipment at IREL MK shall be the basis of acceptance of the equipment by IREL.

• Installation and Commissioning:

IREL shall carryout the installation and commissioning of the machines at designated sites. However Super visory support shall be provided by the Supplier during erection if required. After erection of the machine the party will be intimated to start the commissioning work.

6.0 Guarantee / Warranty:

The tenderer shall guarantee the equipment for design, materials, workmanship and satisfactory trouble fr ee performance for a period of 12 months from the date of commissioning or 18 months from the date of r eceipt whichever is earlier.

- 7.0 Delivery Period:
- 7.1.1 Delivery Period is 120 days from the date of receipt of purchase order.
- 7.1.2 The Company reserves the right to terminate the contract without assigning any reason by giving tw

o weeks' notice and no claim for any loss or damage or compensation for such termination of contract shall be payable by the Company or maintainable against the Company.

- 8.0 Schedule of Payment:
- 8.1.1 70% payment will be released within 30 days of receipt of equipment at IREL MK site and acceptance by the Engineer-in-Charge.
- 8.1.2 20% payment shall be made after erection and successful commissioning of the equipment and mee ting the Performance Guarantee.
- $8.1.3\ 10\ \%$ payment will be made after the Guarantee period OR against submission of a Performance BG (to be submitted after the supply and acceptance) for equivalent value (10% of the total value) valid till the end of the Guarantee period.
- 8.1.4 All the payments are subject to deduction of tax at source as applicable.
- 8.1.5 Payment will be done within 30 days after submitting the proper bill.
- 8.1.6 GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGST/SGST Act 2017, Section 20 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.

11.0 Performance Test:

The performance of the equipment will be tested in the plant during commissioning for satisfactory accept ance as per the parameters specified in Clause No. 17 of RERMS in Technical specifications of the tender.

12.0 Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or performance the services wit hin the time period (s) specified in the CONTRACT, the PURCHASER shall, without prejudice to his other re medies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the CON TRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delivered late, for each week o r part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of the value of delayed goods . The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value shall be reduced proportion ately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the PURCHASER may deduct the amount so payable by SELLER, from any amount falling due to the SELLER or by recovery against the Performance Guarantee. Both seller and PURCHASER agree that the above percentages of price reduction are genuine preestimates of the loss/damage which the PURCHASER would have suffered on account of del ay/breach on the part of the SELLER and the said amount will be payable on demand without there being a ny proof of the actual loss/or damage caused by such breach/delay. A decision of the PURCHASER in the m atter of applicability of price reduction shall be final and binding.

13.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall go vern.

14.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.

15.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.
