If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. ## 9. Warranty

Warranty period of the supplied products shall be 1 years from the date of final acceptance of goods or after completion of installation, commissioning & testing of goods (if included in the scope of supply), at consignee location. OEM Warranty certificates must be submitted by Successful Bidder at the time of delivery of Goods. The seller should guarantee the rectification of goods in case of any break down during the guarantee period. Seller should have well established Installation, Commissioning, Training, Troubleshooting and Maintenance Service group in INDIA for attending the after sales service. **1) Technical Competency: (i)The Bidder or its OEM {themselves or through re-seller(s)} should have successfully executed supply of wire ropes / slings during last Five (5) years ending of bid opening date to any Central/ State Government, Public Sector Undertaking(s) or private organizations. Bidder shall upload documentary evidence in support of the above from concerned authority/department/organization towards supplies executed like Copy of Purchase Order along with proof of delivery/ invoice copy /satisfactory performance of the same.**

**(ii) The bidder should be the manufacturer or their authorized dealer / sub dealer for supply of wire ropes / slings. Manufacturer should submit self declaration towards being manufacturer or submit Udyam certificate towards being manufacturer. Dealer should submit valid authorized dealership certificate from the manufacturer. Sub dealer should submit sub dealership certificate from the dealer along with the dealership certificate from manufacturer**

**NB:** For MSE & start-up bidders, past experience is relaxed. However, bidders have to establish their technical competency by submitting supporting documents towards successful execution of similar work **for any value**, failure to

which the offer will not be considered for evaluation.

## **2. Note:**

**As per para 7.3.5** on (Clarification of Bids/Shortfall Documents) of the Manual for Procurement of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender will be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted.
