OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

PRE-QUALIFICATION CRITERIA

The tenderer should submit the following towards Pre- Qualification Criteria:

- 1. Tenderer should have minimum 2 Nos of crawler mounted excavator of min 0.9 cu.m capacity and mini mum 1 Nos of tyre mounted Wheel Loaders of min.1.5 cu.m in their own name or through hiring whose Manufacturing date should be later than 01/07/2020. Documentary proof of the owning or hiring to be sub mitted. List of Excavators and Loaders with the Documentary proof for their manufacturing date, Ownershi p status and capacity also is to be submitted.
- 2. The tenderer must have experience in successful completion of similar works during the last 7 years end ing 31.05.2025 and the same should be either of the following:

- 2.0 The rate quoted shall be FOR IREL (India) Limited, Manavalakurichi. The items have to be supplied strictly as per the technical specification within the delivery period mentioned in the tender.
- 3.0 Earnest Money Deposit (EMD)
- 2.1 ₹9,52,000/- (Rupees Nine lakh and fifty two thousand only)
- 2.2 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limited, Manavalakurichi.
- 2.3 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. - 2.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the ten der. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-C ommercial Bid.
- 2.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 2.6 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the dat e of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 2.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. M SME /SSI units—are exempted from payment of EMD/ TDC—provided they submit valid MSME/ NSIC certific ate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.
- 3.0 Security Deposit (SD)

- 3.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards sati sfactory completion of the order/works as under:
- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (D LP).

- 4.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guara ntee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 4.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 4.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guar antee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.
- 4.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on aban donment of the supply/ work order.
- 4.0 period of Contract:

The period of contract shall be ten (10) months from the date of start of work or the quantity which is to be transported, whichever is earlier.

5.0 Works during all weekly days:

The contractor shall carryout the works in two shifts on all working days. The shift timings are from 7.00 A M to 3.00 PM and 3.00 PM to 11.00PM. For carrying out the work on Sundays/holidays prior permission from IREL has to be obtained.

- 6.0 Payment Terms:
- a. Payment to the contractor for the work done will be made fortnightly on production of bills and after th e verification of work done with weighbridge statement generated by stores department within 30 days f rom the submission of bills complete in all respect. Penalty for shortfall and deduction as per the variou s clauses in the tender as applicable will be made including statutory deduction such as Income Tax, etc. a s per rules.
- b. No mobilization advance shall be allowed as a general rule.
- c. GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the GST/SGST Act 2017, Section 20 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.
- d. Please mention IREL (India) Limited GST number (33AAACI2799F1ZL) and HSN/SAC code of goods/servic es in your bills.
- e. All payments shall be done only through E-payment. Hence successful bidder has to provide Company n ame, Account number, Name of the bank.
- 7.0 Penalty:
- 8.1 The monthly target quantity area wise to be executed by the contractor has been mentioned in clause C (2.0) and if the monthly target quantity is not fulfilled, penalty along with applicable Goods & Service Tax as specified here shall be levied taking into account the monthly target quantity and actual monthly perfor mance area- wise. The monthly penalty imposed will be equal to the amount of 25%, of the value of the un executed portion of the work (Loading & Transportation cost) or shortfall area wise.
- 8.2 From our past experience it is seen that THREE batches of loading equipment along with required tippe

rs are continuously required for achieving the contractual targeted quantity. At any point of operation, thre e loading equipments should be readily available. However, if failure of any loading equipment occurs, the n it shall be the responsibility of the contractor to immediately make alternate arrangement to mobilize sp are loading equipment of good working condition, either his own or hired from outside agencies. The contractor shall ensure that checking of the spare loading equipment by company official is completed before in ducting the same in the existing fleet. Hence, in case the contractor fails to mobilize spare loading equipment of good working condition within 3 days, he shall be liable to pay penalty @ Rs.25,000/- (Rupees Twen ty five Thousand only) plus applicable Goods & Service Tax per loading equipment for each day of shortfall of loading equipment beyond 3 days (excluding the day on which the equipment failed), till such time the I oading equipment in working condition are mobilized to three numbers.

- 8.3 The company reserves the right not to accept any excess supply over and above the target quantity du e to non-availability of space, blending problem or any other reason.
- 8.4 The shortfall in the targeted quantity shall not be taken into account for calculating penalty incase of n on-availability of required quantity rawsand/tails/SGM etc & for reasons not attributable to the contractor.
- 8.5 For shortfall in targeted quantities the contractor has to submit within 07 days of the following month, the reasons for shortfall.
- 8.6 In case the contractor abandons the work, IREL reserves the right to get the balance works/raw material supply executed in the manner deemed fit through any other agency that IREL may decide and the extra expenditure incurred by IREL for execution of such work will be debited to the contractor's account.
- 8.7 The work shall be continued by the contractor till the time stipulated in the tender and to the satisfacti on of IREL.
- 8.8 The tenderer should note that this tender is linked with the manual collection of beach washings from various societies. Therefore timely collection from the beaches is of paramount importance to ensure the f ollowing:
- a) Area for manual collection is always available and poor performance of the contract should not impact on the earnings of the manual workers.
- b) The heaped sand after manual collection is not carried away due to rough sea waves.
- 8.0 Liquidated Damages for Delayed Execution of Contract:

If the Service Provider fails to perform the services within the time period(s) specified in the CONTRACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be fin all and binding.

- 10.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall go vern.
- 11.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.
- 12.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
