- 1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. - 4. Purchase preference to Micro and Small Enterprises (MSEs): Purchase preference will be given to MSEs as defined in Public Procurement Policy for Micro and Small Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro, Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail the Purchase preference for services, the bidder must be the Service provider of the offered Service. Relevant documentary evidence in this regard shall be uploaded along with the bid in respect of the offered service. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE bidder subject to acceptance of L1 bid price. The buyers are advised to refer to the OM No.1 4 2021 PPD dated 18.05.2023 for compliance of Concurrent application of Public Procurement Policy for Micro and Small Enterprises Order, 2012 and Public Procurement (Preference to Make in India) Order, 2017. Benefits of MSE will be allowed only if the credentials of the service provider are validated online in GeM profile as well as validated and approved by the Buyer after evaluation of submitted documents.

 5. If L-1 is not an MSE and MSE Service Provider (s) has/have quoted price within L-1+ 15% of margin of purchase preference /price band as defined in the relevant policy, then 100% order quantity will be awarded to such MSE
- 6. Estimated Bid Value indicated above is being declared solely for the purpose of guidance on EMD amount and for determining the Eligibility Criteria related to Turn Over, Past Performance and Project / Past Experience etc. This has no relevance or bearing on the price to be quoted by the bidders and is also not going to have any impact on bid participation. Also this is not going to be used as a criteria in determining reasonableness of quoted prices which would be determined by the buyer based on its own assessment of reasonableness and based on competitive prices received in Bid / RA process.
- 7. Past Experience of Similar Services: The bidder must have successfully executed/completed similar Services over the last three years i.e. the current financial year and the last three financial years(ending month of March prior to the bid opening): -
- 1. Three similar completed services costing not less than the amount equal to 40% (forty percent) of the estimated cost; or
- 2. Two similar completed services costing not less than the amount equal to 50% (fifty percent) of the estimated cost; or
- 3. One similar completed service costing not less than the amount equal to 80% (eighty percent) of the estimated cost.

However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

PRE-QUALIFICATION CRITERIA

The bidder should submit the following towards Pre- Qualification Criteria:

1. The bidder shall submit copy of Certificate of authorisation for approved Service Centre for products fro

m M/s Lauritz Knudsen Electrical & Automation LK (L&T) Electrical Standard products.

2. The bidder shall submit all credentials including copies of Purchase order/Work order executed along wit h relevant work completion report OR commissioning report OR Performance certificate OR Tax invoice OR work completion certificate OR Tax invoice for having successfully completed the work (similar work) d uring the last 7 years ending 31st May 2025.

Similar work: Similar work means work involving Servicing of LK (L&T) Make Air circuit breakers (ACBs) in P SU's OR CPSU's OR Government Departments OR Government institutions OR reputed private sector companies.

- 3. The bidder shall submit duly signed and stamped Scope of Work sheets as per our bid.
- 4. Average annual financial turnover during the last 3 years, ending 31st of March 2024 should be at least ₹63,291/- Documentary proof for the same shall be enclosed. (Copy of Profit & Loss account OR balance sh eet for the above).

Note:

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be conside red under any circumstances.
- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-ups (as defined by Depar tment of Industrial Policy and Promotion) as per Government Circular / Guidelines subject to meeting of quality and technical Specification.
- 3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying wi th the obligations as per the contract shall not be considered.
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the Procurement Policy for Micro and small Enterprises, 2012 (as amended time to time).

- 2.0 The rate quoted shall be FOR IREL (India) Limited, Manavalakurichi. The items have to be supplied strictly as per the technical specification within the delivery period mentioned in the tender.
- 3.0 EARNEST MONEY DEPOSIT (EMD)
- 3.1 Tenderer shall remit EMD through RTGS/ NEFT infavour of M/s IREL (India) Limited, Manavalakurichi.
- 3.2 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail should conta in full postal address of the Tenderer, Tender No. for which EMD & TDC were paid, payment details includin g amount, and UTR No. and bank details from which payment was done. - 3.3 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the ten der. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-C ommercial Bid.
- 3.4 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 3.5 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the dat e of opening.

- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 3.6 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. M SME /SSI units—are exempted from payment of EMD/ TDC—provided they submit valid MSME/ NSIC certific ate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.

4.0 SECURITY DEPOSIT (SD)

- 4.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards sati sfactory completion of the order/works as under:
- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (D LP).

- 4.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guara ntee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 4.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 4.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guar antee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.
- 4.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on aban donment of the supply/ work order.

5.0 COMPLETION PERIOD:

The whole work (Supply of Maintenance kit, Servicing of all ACBs and Fixing of Interlock.) shall be complet ed within 60 (Sixty) days from the date of issue of work order.

6.0 PAYMENT TERMS:

100 % payment will be released within 30 days after completion of the whole work (Supply of Maintenance kit, Servicing of the all ACBs and Fixing of Interlock.) against your invoice and certification by the Engineer-In-Charge, subject to deduction of tax at source as applicable.

All the payments are subject to deduction of tax at source as applicable.

Payment will be done within 30 days after submitting the proper bill.

GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGST/SGST Act 2017, Section 20 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.

7.0 LIQUIDATED DAMAGES:

1. In case of delay in completion of the contract, liquidated damaged are to be levied as below:

For delays attributable to the contractor liquidated damages shall be levied at the rate of 1% per week or part thereof on the value of unfinished supply/work for each week of delay subject to a maximum of 10 % of the total contract value.

10.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.

11.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.

- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
