2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including addons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

- 3.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 3.6 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the dat e of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.

- 4.0 Security Deposit (SD)
- 4.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards sati sfactory completion of the order/works as under:
- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (D LP).

- 4.2 Submission of SD/PBG, if called for in the tender can also be paid through Insurance Surety Bonds' or 'account payee demand draft' or 'fixed deposit receipt from a Scheduled Commercial bank' or 'Bank Guara ntee issued/ confirmed from any Scheduled Commercial Banks in India' or online payment to be confirmed sharing Unique Transaction Reference (UTR) to the tender inviting authority as called for in tender.
- 4.3 Bank Guarantees towards Bid Security/ Security Deposit/ PBG issued by Nationalized Banks/ Scheduled Commercial Banks (other than Cooperative Banks) only acceptable.
- 4.4 EMD/ Bid Security may be adjusted towards SD. However, if EMD is submitted in the form of Bank Guar antee, fresh Bank Guarantee in the prescribed format or demand draft/Bankers cheque is to be submitted towards SD.
- 4.5 The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on aban donment of the supply/ work order.
- 5.0 period of Contract:
- 5.1 The period of contract is one year from the date of start of work. If the entire quantity could not be tran sported within one year from the date of start of work due to reasons attributed to IREL, the period of cont act can be further extended for a maximum period of another six months for the balance quantity, if any on mutually agreeable basis of IREL and the successful bidder. The work is to be started within 3 days from the date of intimation received from IREL. It is open to IREL to terminate the contract without assigning an y reason or reasons by giving two weeks notice and no claim for any loss or damage or compensation for such terminations of contract shall be payable by IREL or maintainable against IREL.
- 5.2 The contractor or their responsible representative with full powers, to act in all cases on his behalf mus t be present in the Port during the period of Port operation.
- a) All the workers employed for the purpose of carrying out this contract work will be contractor's workers and it shall be the responsibility of the contractor to pay the workmen all wages and all other dues whatso ever.
- b) Payment to the contractor's workers at the minimum rates fixed or to be fixed later on will have to be p aid and borne by the contractor.
- c) The contractor is solely liable to pay the wages due to the workers employed by him and IREL will not in any way is liable to pay the whole or any part of the same.
- d) Should it become necessary to pay lay-off compensation or any other compensation to the workers em ployed by the contractor as provided for in the Industrial Disputes Act or otherwise it shall be the sole responsibility of the contractor to meet such payments and IREL will not on any account reimburse the same.
- e) Should any dispute or difference arise between the contractor and their workmen or between their work men in relation to the employment or non-employment or terms of employment, it shall be the sole responsibility of the contractor to settle such disputes or difference and payment if any made in that connection shall be borne by the contractor.
- f) Should it become necessary to pay minimum wages or any other material benefits to the labour for any reason, it shall be the sole responsibility of the contractor to do so, according to prevailing rates and contractor will have no claim on IREL for such payments.

6.0 Payment Terms:

- a. Payment will be released after completion of each shipment of export. In case shipment is delayed by m ore than 15 days after completion of transportation of entire material for the shipping at a time, 60% of the rate quoted against SI. No.1 will be released. The contractor shall not be entitled to claim any payment fo r non-shipment / short shipment or for salient cargo or delay in shipment if the space is reserved by buyer s or IREL. It shall be the duty of the contractor to effect shipment expeditiously. All payments to the contractor will be subject to deduction of Income Tax at source as provided in Section 194 (c) of the Income Tax Act. 1961 & other applicable deductions. Payment for items mentioned in SI. No. 2 to 10 in Price Sche dule will be done as & when required. Payment will be carried out as per actual within 30 days.
- b. GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the GST/SGST Act 2017, Section 2 0 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.
- c. Please mention IREL (India) Limited GST number (33AAACI2799F1ZL) and HSN/SAC code of goods/servic es in your bills.
- d. All payments shall be done only through E-payment. Hence successful bidder has to provide Company n ame, Account number, Name of the bank.

7.0 Risk Purchase Clause:

After award of the contract, if the contractor fails to execute the contract as per tender or at any time repu diates the order, IREL have the right to forfeit the EMD/SD and execute the contract through other agencie s at the risk and cost of the contractor. The cost differences between the alternative arrangements and tot al contract value will be recovered from the contractor along with other incidental charges. In case of exec ution of contract through alternative sources and if price is lower, no benefit on this account will be passed on to the contractor.

8.0 Liquidated Damages for Delayed Execution of Contract:

If the Service Provider fails to perform the services within the time period(s) specified in the CONTRACT, the EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Any delay attributed by the contractor in executing and completing the work in excess of the period specified in the work order will attract Liquidated damages @ 0.5% per week or part thereof, subject to a maximum of 10% of the total contract value. This will be recovered from your bills or any payment due to you

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Service Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agree that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be fin all and binding.

- 9.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall gove rn.
- 10.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.
- 11.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.

4. Buyer Added Bid Specific ATC

- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
- 15. Any ATC clause in contravention with GeM GTC Clause 4 (xiii)(h) will be invalid. In case of multiple L1 bidders against a service bid, the buyer shall place the Contract by selection of a bidder amongst the L-1 bidders through a Random Algorithm executed by GeM system.
- 16. Buyer added ATC Clauses which are in contravention of clauses defined by buyer in system generated bid template as indicated above in the Bid Details section, EMD Detail, ePBG Detail and MII and MSE Purchase Preference sections of the bid, unless otherwise allowed by GeM GTC.
- 17. In a category based bid, adding additional items, through buyer added additional scope of work/ additional terms and conditions/or any other document. If buyer needs more items along with the main item, the same must be added through bunching category based items or by bunching custom catalogs or bunching a BoQ with the main category based item, the same must not be done through ATC or Scope of Work.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.
