- 1. If the bidder is a Micro or Small Enterprise (MSE) as per latest orders issued by Ministry of MSME, the bidder shall be exempted from the eligibility criteria of "Bidder Turnover" as defined above subject to meeting of quality and technical specifications. OPTION CLAUSE: The buyer can increase or decrease the contract quantity or contract duration up to 25 percent at the time of issue of the contract. However, once the contract is issued, contract quantity or contract duration can only be increased up to 25 percent. Bidders are bound to accept the revised quantity or duration

2. Generic

Option Clause: Excess Settlement. The excess settlement has been enabled for the service, allowing service providers to include additional charges up to a specified percentage of the item-level total value, including addons, in their invoices. Service providers must declare the applicability of additional charges during invoice creation and submit mandatory supporting documents to avail this option. The total invoice amount, including additional charges, shall not exceed the agreed-upon excess settlement percentage for the order.

- 2.4 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the ten der. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-C ommercial Bid.
- 2.5 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 2.6 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the dat e of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 2.7 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. M SME /SSI units are exempted from payment of EMD/ TDC provided they submit valid MSME/ NSIC certific ate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.
- 3.0 SECURITY DEPOSIT (SD),
- 3.1 Security deposit (SD) shall be uniformly levied @ 5% of contract value (excluding Taxes) towards sati sfactory completion of the order/works as under:
- a. For works contract valued more than Rs.2 lakhs.
- b. For supply & service contract valued more than Rs.5 lakhs.

Performance Security is to be furnished by a specified date (generally 14 (fourteen) days after notification of the award) and it should remain valid for a period of 60 (sixty) days beyond the date of completion of all contractual obligations of the supplier/ contractor, including warranty obligations/ defect liability period (D LP).

4.0 Period of Contract

The Period of contract is one year from the date of start start of work and shall start the work within 15 da ys from the date of work order and shall continue for a period of One year (1 year), unless it is curtailed or terminated by IREL(India) Limited .

5.0 Penalty

- 1. The contractor shall immediately provide a competent substitute in the event of any person leaving the site due to his / her personal reasons. The delay by the contractor in providing a substitute beyond one wo rking day shall attract damages $@ {3250}$ per day (per such case) on the contractor.
- 2. Compensation for interruption of service rendered, cost of materials or stores lost or damaged while car rying out the work, or cost of materials or stores not returned to this office on completion of work or cost of defective components, spares or tools, or towards damage of other utility services while carrying out the work, or any claim against you for the payment of money arises out of or under this contract will be deduct ed from the monthly bill or any other amount payable to you.
- 3. In case, you fail to comply with any statutory / taxation liability under appropriate law, and as a result th ereof this office is put to any loss / obligation, monitory or otherwise, This office will be entitled to get itself reimbursed out of the outstanding bills or the performance Security Deposit of you., to extent of the l oss or obligation in monitory terms.
- 4. In case, person deployed is absent on a particular day, that day's wage shall be deducted.

6.0 Payment Terms

- 1. The payment shall be made on pro-rata basis as per the minimum wages Contract Labour (Regulation a nd Abolition) on a monthly basis for the number of mandays engaged within 30 days of submission of bill d uly certified by Officer-in-charge.
- 2. All payments are subject to deduction of tax at source as applicable.
- 3. GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGST/SGST Act 2017, Section 20 of the IGST Act, 2017and Section 21 of the UTGST Act, 2017.

STORES DEPARTMENT

7.0 Penalty:

During the contract period, the contractor fails to provide the manpower for more than 2 days per person (4 man days) in a month, the contractor shall be liable to pay penalty ⊚₹400/- per day (per person) for each day's non deployment beyond two days.

8.0 Working Hours:

Work hours shall be between 8.00 AM to 4.00 PM on all working days, holidays & Sunday (after allowing fo r formalities connected with documentation, site briefing etc). However based on a written request from the contractor IREL (India) Limited may consider, in deserving conditions, extension of working hours beyond what is stipulated above and such extension shall be granted formally.

9.0 Period of Contract:

- a. The period of contract will be for a period of one year up to full quantity on the discretion of IREL (India) Ltd on satisfactory performance of the contract.
- b. IREL may terminate the contract by issuing two weeks' notice without assigning any reasons. Further th e contract may also be terminated by IREL during the subsistence of the contract if any of the terms and c onditions of the contract is not complied with by the contractor.
- c. If more than one bidder quotes same L-1 price, i.e., in case a tie exists between two or more bidders on quoted price, preference will be given to bidder as mentioned below. (L-1 party will be finalized based on t he following sequence of priorities.)
- d. if more than one bidder of L-1 price exists, Run for L-1 method from GeM portal will be adopted.

10.0 Payment Terms

- a. Payment will be released monthly on pro-rata basis after satisfactory completion of work against contra ctor's bill duly certified by Officer-in-Charge, subject to deduction of tax at source as applicable. All payme nts will be done only through E - payment. Hence the contractor has to provide the complete bank details along with GST registration details.
- b. GST Law mandates Tax Deduction at Source (TDS) vide section 51 of the CGST/SGST act 2017, section 2 0 of the IGST act 2017 and section 21 of the UTGST act 2017.
- c. Our GSTIN 33AAACI2799F1ZL and SAC code of service is to be mentioned in the bills.
- d. All the payment will be done only through e-payment. Hence, you have to provide your name, account no., name of the bank, and nature of account (savings/current/CC/OD), IFSC, branch code and cancelled ch eck along with invoice.

11.0 LIQUIDATED DAMGES FOR DELAYED EXECUTION OF CONTRACT:

If the Service Provider fails to perform the services within the time period(s) specified in the CONTRACT, th e EMPLOYER shall, without prejudice to his other remedies under the CONTRACT, levy Liquidated damages from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula:

Half percent (0.5%) of the contract value per week of delay subject to a maximum of ten percent (10%) of contract value.

EMPLOYER may deduct the amount so payable by Service Provider, from any amount falling due to the Ser vice Provider or by recovery against the Performance Guarantee. Both Service Provider and EMPLOYER agr ee that the above percentages of price reduction are genuine pre-estimates of the loss/damage which the EMPLOYER would have suffered on account of delay/breach on the part of the Service Provider and the said amount will be payable on demand without there being any proof of the actual loss/or damage caused by such breach/delay. A decision of the EMPLOYER in the matter of applicability of price reduction shall be fin al and binding.

- 13.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall go
- 14.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by I REL shall govern.
- 15.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
