### **Bid Corrigendum**

#### GEM/2025/B/6798552-C1

Following terms and conditions supersede all existing "Buyer added Bid Specific Terms and conditions" given in the bid document or any previous corrigendum. Prospective bidders are advised to bid as per following Terms and Conditions:

# **Buyer Added Bid Specific Additional Terms and Conditions**

- 1. OPTION CLAUSE: The Purchaser reserves the right to increase or decrease the quantity to be ordered up to 25 percent of bid quantity at the time of placement of contract. The purchaser also reserves the right to increase the ordered quantity up to 25% of the contracted quantity during the currency of the contract at the contracted rates. The delivery period of quantity shall commence from the last date of original delivery order and in cases where option clause is exercised during the extended delivery period the additional time shall commence from the last date of extended delivery period. The additional delivery time shall be (Increased quantity ÷ Original quantity) × Original delivery period (in days), subject to minimum of 30 days. If the original delivery period is less than 30 days, the additional time equals the original delivery period. The Purchaser may extend this calculated delivery duration up to the original delivery period while exercising the option clause. Bidders must comply with these terms.

## PRE QUALIFICATION CRITERIA

Tenderer should the below documents towards Pre-Qualification Criteria

- 1. The bidder shall be OEM/ OEM authorised dealer/ stockist of the offered Make or Brand of the energy eff icient, squirrel cage induction Motors. The Make shall be "SIEMENS" OR "KIRLOSKAR ELECTRIC COMPANY" OR "CROMPTON GREAVES" OR "BHARATH BIJLEE" OR "ABB" OR "LHP" OR "HAVELLS" OR "NEW BHARAT". Any other make quoted shall not be accepted. Documentary proof in support of the same to be furnished. (Copy of the valid authorization certificate or letter to be furnished).
- 2. The bidder shall submit duly signed and stamped Technical specification sheet as per our NIT.
- 3. The bidder should have an experience of having successfully completed similar Supply OR Works in PSU 's OR CPSU's OR Government Departments OR Government institutions OR reputed private sector compa nies during last 7 years ending 30th September 2025. The bidders shall, in support of the above, submit d ocumentary evidence towards work executed like copy of Purchase OR Work order along with relevant S upply OR Work completion certificate OR Tax invoice OR Delivery challan as detailed below.
- a. Three (3) similar completed Supply OR Works costing not less than the amount equal to \$1,95,275/-.

- b. Two (2) similar completed Supply OR Works costing not less than the amount equal to \$2,44,094/-.
- c. One (1) similar completed Supply OR Works costing not less than the amount equal to ₹3,90,550/-.
- "Similar supply OR works means supply of energy efficient, squirrel cage induction Motor of capacity 1.5 K W/2 HP or higher size and Efficiency Class IE3 or higher size".
- 4. Average annual financial turnover during the last 3 (three) years, ending 31st of March 2024 should be at least ₹1,46,456/- Documentary proof for the same shall be enclosed.

Note:

- 1. In the absence of receipt of documents meeting to Pre-qualification criteria, the offer will not be considered under any circumstances.
- 2. Relaxation in prior turnover and prior experience shall be given to MSEs / Start-ups (as defined by Depa rtment of Industrial Policy and Promotion) as per Government Circular / Guidelines subject to meeting of quality and technical Specification.
- 3. The offers of the bidders who have defaulted in the past in execution of the contracts or in complying w ith the obligations as per the contract shall not be considered.
- 4. Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the Procurement Policy for Micro and small Enterprises, 2012 (as amended time to time).

#### Other Terms & Conditions

- 1.0 The Party has to upload the following along with the Bid
- (i) Documents towards pre qualification of tender failing which offer shall not be accepted.
- (ii) Copy of GST, PAN, MSME Registration
- (iii) EMD Declaration
- (iv) Undertaking provided in tender, duly filled and signed
- (v) Contact details with e-mail, Phone no. etc.
- 2.0 The rate quoted shall be FOR IREL (India) Limited, Manavalakurichi. The items have to be supplied strictly as per the technical specification within the delivery period mentioned in the tender.
- 3.0 Delivery Period

Delivery shall be completed within 30 days from the date of issue of purchase order.

- 4.0 Earnest Money Deposit (EMD)
- 4.1 Tenderer shall remit EMD through RTGS/ NEFT in favour of M/s IREL (India) Limited, Manavalakurichi.
- 4.2 Tenderer shall inform details of remittance of EMD & TDC through E-Mail/ FAX. The E-mail should cont ain full postal address of the Tenderer, Tender No. for which EMD & TDC were paid, payment details including amount, and UTR No. and bank details from which payment was done. IREL's Email id is purchase-mk @irel.co.in
- 4.3 Incase tenderer is submitting BG in lieu of EMD the same shall be strictly in the format given in the ten der. The Original BG shall reach this office at least 3 days in advance from the date of opening of Techno-Commercial Bid.
- 4.4 Offers without EMD or valid EMD exemption certificate shall not be considered.
- 4.5 The EMD is liable to be forfeited if:
- i. The tenderer changes the terms and conditions or prices or withdraw his quotation subsequent to the da te of opening.
- ii. The tenderer fails to accept the order when placed or fails to commence supplies/works after accepting the order.
- iii. In case bidder submits false/fabricated documents.
- iv. In case bidder fails to submit SD within 30 days of receipt of work/supply order.
- 4.6 PSU, State Govt. Undertakings are exempted from payment of EMD subject to request and approval. MSME /SSI units are exempted from payment of EMD/ TDC provided they submit valid MSME/ NSIC certificate along with commercial bid and to ensure that certificate pertains to the class of item/works for which floated.
- 4.7 Traders/ distributors/ sole agent/ Works Contract are excluded from the purview of the Procurement Po

licy for Micro and small Enterprises, 2012 (as amended time to time).

5.0 Security Deposit (SD) (For supply orders above ₹ 5 Lakhs)

The successful tenderer has to submit Security Deposit @5% of the contract value in the form of RTGS/NE FT/ BG within 21 days of receipt of our PO as security for satisfactory completion of the order. The SD shall not bear any interest and is liable to be forfeited for unsatisfactory completion or on abandonment of the supply order. The EMD can be adjusted towards Security Deposit. However, if EMD is submitted in the for m of BG, fresh BG is to be submitted towards SD in the prescribed format as per tender. If the Supplier fail s to provide the security deposit within the period specified, such failure shall constitute a breach of the C ontract and IREL shall be entitled to make other arrangements for the repurchase of the stores contracted for at the risk and expense of the supplier and/or to recover from the supplier the damages arising from su ch cancellation.

### 6.0 Payment terms

Our standard payment term is 100% payment within 30 days from the date of receipt and acceptance of materials along with all relevant documents" NO advance payment shall be made under any circumstanc es. Interest @ 12% shall be considered for evaluation of bids in case of supplier(s)/contractor(s) requestin g for payment earlier than our stipulated terms.

GST Law mandates Tax Deduction at Source (TDS) vide Section 51 of the CGST/SGST Act 2017, Section 20 of the IGST Act, 2017 and Section 21 of the UTGST Act, 2017.

Please mention IREL GST number (33AAACI2799F1ZL) and HSN/SAC code of goods/services in your bills.

#### 7.0 Liquidated Damages

Subject to Article -25, if the SELLER fails to deliver any or all of the GOODS or performance the services wi thin the time period (s) specified in the CONTRACT, the PURCHASER shall, without prejudice to his other re medies under the CONTRACT, deduct from the CONTRACT PRICE, a sum calculated on the basis of the CONTRACT PRICE, including subsequent modifications.

Deductions shall apply as per following formula

A sum equivalent to 0.5 (Half) per cent of the prices of any portion of stores delivered late, for each week or part thereof of delay. The total damages shall not exceed 10 (Ten) per cent of the value of delayed goo ds. The LD cannot exceed the amount stipulated in the contract.

In case of delay in delivery on the part of SELLER, the invoice/document value shall be reduced proportion ately for the delay and payment shall be released accordingly.

In the event the invoice value is not reduced proportionately for the delay, the PURCHASER may deduct the amount so payable by SELLER, from any amount falling due to the SELLER or by recovery against the Pe rformance Guarantee. Both seller and PURCHASER agree that the above percentages of price reduction ar e genuine preestimates of the loss/damage which the PURCHASER would have suffered on account of dela y/breach on the part of the SELLER and the said amount will be payable on demand without there being a ny proof of the actual loss/or damage caused by such breach/delay. A decision of the PURCHASER in the matter of applicability of price reduction shall be final and binding.

11.0 In case of any discrepancy between Gem ATC and Buyer ATC, terms stipulated in Buyer ATC shall go vern.

12.0 In case of any discrepancy between GeM SLA terms and ATC stipulated by IREL, Terms stipulated by IREL shall govern.

13.0 MSE bidders are to carefully indicate their MSE status while bidding. In case any mistake done by the bidder, evaluation and order shall be done as per GeM provisions only and IREL (India) Limited shall not be anyway held responsible.

- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.

- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.
