1. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- Copy of PAN Card.
- Copy of GSTIN.
- Copy of Cancelled Cheque.

3. Generic

Data Sheet of the product(s) offered in the bid, are to be uploaded along with the bid documents. Buyers can match and verify the Data Sheet with the product specifications offered. In case of any unexplained mismatch of technical parameters, the bid is liable for rejection.

(i) In case the bidder offers equivalent make (other than PBL make), the detailed drawings of the geared motor offered shall be submitted with offer. Offer without drawings will not be considered.

(ii) In case the bidder offers equivalent make (other than PBL make), the bidder has to give an exact fitment certificate stating that their offered model is an exact fitment for one to one replacement against the PBL make model currently in use and mentioned in tender.

(iii) The decision of IREL regarding exact fitment against the indented models shall be final and binding on bidders to accept.

(iv) Geared Motor should be supplied with factory filled synthetic grease for life time lubrication.

1. Technical competency: The Bidder or its OEM {themselves or through re-seller(s)} should have supplied Geared Motor of minimum order value Rs.12 Lakhs in a (single or two orders) in last five years ending bid opening date to any Central / State Govt. Organization / PSU / Public Listed Company / private organizations. Copies of relevant contracts (providing supply of along with completion proof like tax invoice / CRAC / E-way bills etc to be submitted along with bid in support of quantity supplied.

NB: For MSE Bidders Past experience is relaxed. However, bidders have to establish their technical competency by submitting supporting documents towards successful execution of similar work **for any value**, failure to which the offer will not be considered for evaluation.

2) Note: As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Procurement of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During evaluation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clarifications on the bid. The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender will be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted. 8. Turnover
