If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. - II) **Payment Terms (As per GEM GTC) i.e.** 100% payment will be released within ten (10) days of issue of consign ee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills.

III)Liquidated Damages (LD):

If the Seller/Service Provider fails to deliver any or all of the Goods/Services within the original/re-fixed deli very peri od(s) specified in the contract, the Buyer will be entitled to deduct/recover the Liquidated Damages for the delay, u nless covered under Force Majeure conditions aforesaid, @ 0.5% of the contract value of delayed quantity per week or part of the week of delayed period, until actual delivery or performance, as p re-estimated damages not exceedin g 5% of the total contract value without any controversy/dispute of an y sort whatsoever. 8. Warranty

The seller should guarantee the rectification of goods in case of any break down during the guarantee period.
