The r equest for clarification shall be given asking the tenderer to respond by a specified date. If the tendere r does not comply or respond by the date, his tender will be liable to be rejected. Depending on the out come, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted.
