#### 1. Generic

Bidders are advised to check applicable GST on their own before quoting. Buyer will not take any responsibility in this regards. GST reimbursement will be as per actuals or as per applicable rates (whichever is lower), subject to the maximum of quoted GST %.

#### 2. Generic

Bidder shall submit the following documents along with their bid for Vendor Code Creation:

- a. Copy of PAN Card.
- b. Copy of GSTIN.
- c. Copy of Cancelled Cheque.
- d. Copy of EFT Mandate duly certified by Bank.

#### 3. Generic

The seller is required to print logo as per buyer's requirement.

#### 4. Generic

Without prejudice to Buyer's right to price adjustment by way of discount or any other right or remedy available to Buyer, Buyer may terminate the Contract or any part thereof by a written notice to the Seller, if:

i) The Seller fails to comply with any material term of the Contract.

ii) The Seller informs Buyer of its inability to deliver the Material(s) or any part thereof within the stipulated Delivery Period or such inability otherwise becomes apparent.

iii) The Seller fails to deliver the Material(s) or any part thereof within the stipulated Delivery Period and/or to replace/rectify any rejected or defective Material(s) promptly.

iv) The Seller becomes bankrupt or goes into liquidation.

v) The Seller makes a general assignment for the benefit of creditors.

vi) A receiver is appointed for any substantial property owned by the Seller.

vii) The Seller has misrepresented to Buyer, acting on which misrepresentation Buyer has placed the Purchase Order on the Seller.

#### 5. Generic

While generating invoice in GeM portal, the seller must upload scanned copy of GST invoice and the screenshot of GST portal confirming payment of GST.

# 6. Scope of Supply

Scope of supply (Bid price to include all cost components) : Only supply of Goods

#### 7. Turnover

Bidder Turn Over Criteria: The minimum average annual financial turnover of the bidder during the last three years, ending on 31st March of the previous financial year, should be as indicated in the bid document. Documentary evidence in the form of certified Audited Balance Sheets of relevant periods or a certificate from the Chartered Accountant / Cost Accountant indicating the turnover details for the relevant period shall be uploaded with the bid. In case the date of constitution / incorporation of the bidder is less than 3 year old, the average turnover in respect of the completed financial years after the date of constitution shall be taken into account for this criteria.

# 8. Buyer Added Bid Specific ATC

Buyer Added text based ATC clauses

1. As per para 7.3.5 on (Clarification of Bids/Shortfall Documents) of the Manual for Procure ment of Goods 2017, issued by Ministry of Finance, Department of Expenditure, During eva luation and comparison of bids, the purchaser may, at his discretion, ask the bidder for clari fications on the bid. The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender w ill be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or per mitted. No post bid clarification at the initiative of the bidder shall be entertained. The sho rtfall information / documents should be sought only in case of historical docume

nts which pre-existed at the time of the tender opening and which have not unde rgone change since then. So far as the submission of documents is concerned with rega rd to qualification criteria, after submission of the tender, only related shortfall documents should be asked for and considered. For example, if the bidder has submitted a suppl y order without its completion / performance certificate, the certificate can be as ked for and considered. However, no new supply order should be asked for so as to qualify the bidder.

# 2. As per section 7.3.1 of Manuals for procurement of Goods, the offer shall be declared as unres ponsive and be ignored during the initial scrutiny if:

i) The offer is not in the prescribed format or is unsigned or not signed as per the stipulations in the bid do cument.

ii) The required EMD has not been provided or exemption from EMD is claimed without acceptable proof of exemption;

iii) The bidder is not eligible to participate in the bid as per laid down eligibility criteria(example: the tende r enquiry condition says that the bidder has to be a registered MSE unit but the tenderer is a, say, a large s cale unit);

iv) The tenderer has quoted for goods manufactured by a different firm without the required authority lette r from the proposed manufacturer.

v) The bid departs from the essential requirements specified in the bidding document (for example, the te nderer has not agreed to give the required performance security); or

vi) Against a schedule in the list of requirements in the tender enquiry, the tenderer has not quoted for the entire requirement as specified in that schedule (example: in a schedule, it has been stipulated that the te nderer will supply the equipment, install and commission it and also train the purchaser's operators for op erating the equipment. The tenderer has, however, quoted only for supply of the equipment).

- **3.** The Bidder or its OEM {themselves or through re-seller(s)} should have printing and supply of stationeries during last five years ending bid opening date to any Central / State Govt. Organization / PSU / Public Liste d Company. Copies of relevant contracts (proving supply of cumulative order quantity in any one financial year) to be submitted along with bid in support of quantity supplied in the relevant Financial year. In case of bunch bids, the category related to primary product having highest bid value should meet this criterion.
- **4.** Pre-Qualification Criteria can be relaxed as per prevailing norms for MSEs, MII and Startup companies subje ct to meeting quality and technical specification.
- 5. Offers from vendors defaulted to IREL (India) Limited, OSCOM during last one year will not be considered.
- 6. Payment Terms (As per GeM GTC) i.e. 100 % payment will be released within 10 (Ten) days of issue of consignee receipt-cum-acceptance certificate (CRAC) and on-line submission of bills.
