- 1. 12. SPECIAL CONDITIONS OF CONTRACT:

SCOPE OF CONTRACT/WORK:

The scope of supply includes and not limited to supply of one bank of Gravity Spiral Separator/Concentr ators- with 4 nos. twin start 7 turn along with accessories. (One nos. of bottom entry distributor and 3 la unders for products i.e., concentrate, middling and tailings) as per detailed specification, terms and con ditions furnished in the tender including transportation to OSCOM stores on FOR Destination basis.

Unloading will be done at OSCOM stores by IREL

Erection and commissioning of equipment shall be done by IREL at its site.

<u>TIME PERIOD OF COMPLETION:</u> The order shall be fully supplied within **196 days (28 weeks)** from the date of acceptance of GA drawing.GA drawing shall be submitted within 7 days of release of order.

TERMS OF PAYMENT

- a. 90% payment along with 100% taxes and duties shall be made towards supply against tax invoice wi thin 30 days of receipt & acceptance of the equipment at IREL, OSCOM Stores.
- b. Balance 10% shall be paid after erection and successful commissioning of the equipment or 06 mont hs from date of supply whichever is earlier.
- C. If any bidder proposes for a payment term other than the above, IREL reserves the absolute right to accept or reject the term and decision of IREL shall be final and binding to all the parties. For evaluat ion of offers, loading shall be made at the rate of 12% per annum for variations in payment terms.

MODE OF PAYMENT:

The payment shall be released after deducting the following:

- a. Compensation recoverable if any.
- b. LD recoverable, if any.
- c. Recoveries on account of contractee's facilities and services, if any.

PACKAGING SITE HANDLING, STORAGE OF MATERIALS & EQUIPMENTS:

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioration, da mage or breakage during shipment, handling and storage in a tropical climate, ideally in wooden carton s. All exposed ferrous metal surfaces shall be covered with a suitable rust preventive compound of reputed make. Large items shall be individually crated

MARKING ON PACKAES:

Each package will be marked on three sides with proper paint/indelible ink, the following (1) Purchaser Name & Address (2) Item Nomenclature (3) Order/Contract No. (4) Packing list reference number

INSURANCE:

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or damage d uring transportation/shipment and handling. For delivery of goods to the purchaser's premises, it is advised that insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the goods from "Warehouse to warehouse" (final destinations) on "All Risks" basis including War Risks and Strikes.

TRANSPORATION:

Delivery of the equipment/materials to IREL, (India) Ltd, OSCOM, Matikhalo shall be done by the contractor at their risk and cost.

UNLOADING, HANDLING:

- a. Unloading at site shall be done by IREL at its cost.
- b. Any incidental expenses at IREL other than unloading charges shall be borne by the supplier

c. Procedure for unloading and handling shall be communicated by the supplier to IREL well in advance

INSPECTION

The items will be inspected by IREL on receipt at IREL site. You may at your option depute your represe ntative for carrying out joint inspection at site or else IREL may conduct inspection on its own. If it is fou nd that any item does not conform to the specification given, or is defective in any manner, the same will be rejected and supplier should arrange for immediate replacement thereof, free of cost to us inclusive of all taxes and duties. Such replacement supplies will also be subjected to our inspection as above before acceptance. However, such supplies, if delayed beyond the period of contract will be considered as late supply and will attract Liquidated damages.

TESTING AND COMMISSIOING:

IREL will install the machine at its site within a period of **3 months** from the date of delivery and shall t est and Commission of the entire system at site. If so, required by IREL, the manufacturer's / supplier's trained engineer/ technician shall extend necessary technical supervisory supports during installation a nd commissioning.

Performance test of spirals:

The performance of the spirals in the plant shall be evaluated based on the quality and recovery in concentrate fraction. As per the present plant operation condition, the propose d spiral separator should be suitable to treat feed material of following specifications:

Feed composition: Heavy Mineral composition>80%

Spiral products: Concentrate:

Grade: HM>90%

HM Recovery > 90%

FINAL ACCEPTANCE CERTIFICATE (FAC):

The FAC will be issued by the PURCHASER only on demonstration of the technical specifications. The wa rranty shall commence only from the date of the issuance of the FAC.

DOCUMENTS TO BE SUBMITTED:

The following documents (in English) shall be provided along with the Unit in both hardcopy and softcop y forms:

- b. Operation and maintenance manuals
- c. troubleshooting procedures
- d. Wiring and other schematic diagrams

- f. If there are any bought-out systems and components, manuals of these are desirable to be provided in hard/softcopy.
- g. Safety and security instruction manual should be provided.
- h. Warrantee certificates as applicable

LIQUIDATED DAMAGES FOR DELAY IN EXECUTION OF CONTRACT

For delays attributable to the contractor, liquidated damages shall be levied at the rate of @ 0.5% per week or part thereof on the total value of the contract subject to a maximum of 10 % of the total value of the contract. (For calculation of LD, the delivery for effecting complete supply of items to IREL's stores only would be considered). The liquidated damage will be recovered from any outstanding bills or amount due to the successful bidder.

WARRANTEE:

The materials/equipment's and all accessories supplied shall be warranted against any defective material, malfunctioning or poor workmanship for a minimum period of 12 months from the date of installation and commissioning as indicated in FAC or 18 months from the date of supply, whichever is earlier.

OTHER TERMS AND CONDITIONS:

- a. The supplier shall include all other equipment /components/ instruments etc. which are not described herein specifically but are deemed necessary for completeness, safety and satisfactory performance of the supply under their scope.
- b. The equipment/components supplied shall have high degree of reliability, the supplier shall offer & s upply equipment/components of proven design, excellent workmanship and proven industrial runnin g record. All materials supplied by the contractor shall be of good quality conforming to relevant an d applicable standards for use in India and shall be suitable for the service specified.

- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for <u>attached categories</u>, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is also governed by the General Terms and Conditions/ यह बिड सामान्य शर्तों के अंतर्गत भी शासित है

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
