- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. If the bidder is OEM of the offered products, it would be exempted from the "OEM Average Turnover" criteria also subject to meeting of quality and technical specifications. In case any bidder is seeking exemption from Turnover / Experience Criteria, the supporting documents to prove his eligibility for exemption must be uploaded for evaluation by the buyer.
- 2. Enterprises (MSEs) Order, 2012 dated 23.03.2012 issued by Ministry of Micro. Small and Medium Enterprises and its subsequent Orders/Notifications issued by concerned Ministry. If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. Traders are excluded from the purview of Public Procurement Policy for Micro and Small Enterprises and hence resellers offering products manufactured by some other OEM are not eligible for any purchase preference. Copies of relevant contracts (providing supply of along with completion p roof like tax invoice / CRAC / E-way bills etc to be submitted along with bid in support of quantit y supplied.

NB: For MSE & Start-Up Bidders Past experience is relaxed. However, bidders have to establish their technical competency by submitting supporting documents towards successful execution of similar work **for any capacity**, failure to which the offer will not considered for evaluation.

IV) SPECIAL CONDITIONS OF CONTRACT

Regulations, Acts, Standards & Codes to be followed:

The design, manufacture and testing of the VFD Panels covered in this specification shall comply with the appropriate standards amended upto September 2024. Unless otherwise specified, I ndian Standards shall be followed. In case where suitable Indian Standards are not available, ge nerally accepted codes and practices as mutually agreed upon shall be adopted. The equipments shall comply with the statutory requirements of the Govt. of India. The equipment and installation shall conform to the provision of statutory and other regulations in force such as Indian Electricity Act etc. The successful bidder shall provide the necessary support like drawings, dat a etc as required by the statutory authorities. In cases where the offer deviates from the specified standards, the successful bidder shall indicate clearly in his offer the standards proposed to be adopted by him and the details thereof.

Scope:

The scope of supply includes and not limited to

- (i) Supply of VFD Starter Feeders in compliance with the technical specifications mentioned in Annexure 1; including loading and transporting upto IREL (INDIA) LIMITED OSCOM site.
- (ii) As may be required to carry out inspection in presence of purchaser/purchaser's representa tive before dispatch. The necessary certificate is to be furnished by the party at the time of inspection by the purchaser.
- (iii) Installation and Commissioning at site.
- (iv) To stand warranty as per warrantee clause mentioned below.

TIME PERIOD OF COMPLETION:

- (i) The delivery schedule shall be within **90 days** from the date of approval of GA drawing which is to be submitted within fifteen days of receipt of the P.O and M/s IREL (India) Limited shall a prove the drawing within five (05) days of receiving the drawings from the executing firm. Any delay in supply of the VFD Panels beyond 90 days shall attract LD as per the LD Clause.
- (ii) The successful bidder shall have to give intimation beforehand i.e. **10 days in advance** so that M/s IREL (India) Limited can depute its representative for Pre-Dispatch inspection. On ascer taining the inspection tests and trial run, clearance shall be given for dispatch of the starter fee ders.
- (iii) The VFD Panels shall be erected / installed by the authorized service engineer within 60 days of supply of the material at Central Stores of OSCOM Unit. Any delay beyond 60 days shall at tract imposition of LD as per the LD clause.

TERMS OF PAYMENT:

- (i) 80% payment (along with payment of 100% of GST) of supply part shall be released within 3 0 days of receipt of material at IREL(India)Limited, OSCOM Central Stores and accepted by Engi neer in Charge.
- (ii) Balance 10% payment of supply part along with 90% of the Installation cost (ICT) (along wit h 100% of GST) shall be released within 30 days of receipt of bills post completion of installation and commissioning and accepted by EIC.
- (iii) Balance 10% of the supply part and 10% of the ICT part will be released after completion of warrantee period.

(iv) The Security Deposit / PBG shall be released after three (02) months from the date of comp letion of warrantee period.

All bills/ invoices are to be certified by EIC. The successful bidder has to submit commercially cl ear invoice/ bills in order to enable IREL (India) Limited avail Tax credit on the materials supplie d.

MODE OF PAYMENT:

The additional terms and conditions have been incorporated by the Buyer after approval of the Competent Authority in Buyer Organization, whereby Buyer organization is solely responsible for the impact of these clauses on the bidding process, its outcome, and consequences thereof including any eccentricity / restriction arising in the bidding process due to these ATCs and due to modification of technical specifications and / or terms and conditions governing the bid. If any clause(s) is / are incorporated by the Buyer regarding following, the bid and resultant contracts shall be treated as null and void and such bids may be cancelled by GeM at any stage of bidding process without any notice:-

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

All GeM Sellers / Service Providers are mandated to ensure compliance with all the applicable laws / acts / rules including but not limited to all Labour Laws such as The Minimum Wages Act, 1948, The Payment of Wages Act, 1936, The Payment of Bonus Act, 1965, The Equal Remuneration Act, 1976, The Payment of Gratuity Act, 1972 etc. Any non-compliance will be treated as breach of contract and Buyer may take suitable actions as per GeM Contract.

This Bid is also governed by the General Terms and Conditions/ यह बिड सामान्य शर्तों के अंतर्गत भी शासित है

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
