- 1. If the bidder is a Micro or Small Enterprise as per latest definitions under MSME rules, the bidder shall be exempted from the requirement of "Bidder Turnover" criteria and "Experience Criteria" subject to meeting of quality and technical specifications. SPECIAL CONDITIONS OF CONTRACT

SCOPE OF CONTRACT/WORK:

Supply of 3 no 5 TPH **Induced Roll Magnetic Separator (IRMS)** of proven design used for mineral separ ation as per detailed specification terms and conditions furnished in the tender including transportation to OSCOM stores on FOR Destination basis.

Unloading will be done by IREL at OSCOM stores

Erection and commissioning of equipment shall be done by IREL at its site. The supplier shall extend super visory support for commissioning of the equipment, if required by IREL, at no extra cost to IREL.

TIME PERIOD OF COMPLETION:

The delivery schedule shall be **25 weeks** from the date of approval of GA drawing. The GA drawing shall be furnished to IREL (India) Ltd within 7 days from the date of receipt of the purchase order.

TERMS OF PAYMENT

- a. 90% payment along with 100% taxes and duties shall be made towards supply against tax invoice within 30 days of receipt & acceptance of the equipment at IREL, OSCOM Stores.
- b. Balance 10% shall be paid after successful erection and commissioning of the equipment or 04 months fr om date of supply whichever is earlier.

Note:

EPBG/BG shall be released on satisfactory performance of the equipment during the entire warrantee perio d (12 months from the date commissioning OR 18 months from the date of supply whichever is earlier).

The bidder shall quote on terms of price FOR OSCOM unit, Matikhalo, Ganjam Dt, Odisha. The rate quoted shall be in Indian Rupees only and commissioning supports shall be provided at site ,if required by IREL at no extra cost .

If any bidder proposes for a payment term other than the above, IREL reserves the absolute right to accept or reject the term and decision of IREL shall be final and binding to all the parties. For evaluation of offers, I oading shall be made at the rate of 12% per annum for variations in payment terms.

MODE OF PAYMENT:

The payment shall be released after deducting the following:

- a) Compensation recoverable if any.
- b) LD recoverable, if any.
- c) Recoveries on account of contractee's facilities and services, if any.
- d) Deduction, if any, towards re-coupment of any amounts forfeited, adjusted, deducted out of security deposit.

- g) Any other deduction related to this contract.

PACKAGING SITE HANDLING, STORAGE OF MATERIALS & EQUIPMENTS:

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioration, dama ge or breakage during shipment, handling and storage in a tropical climate, ideally in wooden cartons. All exposed ferrous metal surfaces shall be covered with a suitable rust preventive compound of reputed mak e. Large items shall be individually crated

MARKING ON PACKAGES:

Each package will be marked on three sides with proper paint/indelible ink, the following (1) Purchaser Na me & Address (2) Item Nomenclature (3) Order/Contract No. (4) Packing list reference number

INSURANCE:

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or damage duri ng transportation/shipment and handling. For delivery of goods to the purchaser's premises, it is advised t hat insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the goods fro m "Warehouse to warehouse" (final destinations) on "All Risks" basis including War Risks and Strikes.

TRANSPORATION:

Delivery of the equipment/materials to IREL, (India) Ltd, OSCOM shall be done by the contractor at their risk and cost.

UNLOADING, HANDLING:

a. Unloading at site shall be done by IREL at its cost.

b.Any incidental expenses at IREL other than unloading charges shall be borne by the supplier

c.Procedure for unloading and handling shall be communicated by the supplier to IREL well in advance.

INSPECTION

The items will be inspected by IREL on receipt at IREL site. You may at your option depute your representat ive for carrying out joint inspection at site or else IREL may conduct inspection on its own. If it is found that any item does not conform to the specification given, or is defective in any manner, the same will be rejected and supplier should arrange for immediate replacement thereof, free of cost to us inclusive of all taxes and duties. Such replacement supplies will also be subjected to our inspection as above before acceptance. However, such supplies, if delayed beyond the period of contract will be considered as late supply and will at tract Liquidated damages.

TESTING AND COMMISSIOING:

IREL will install the machine at its site within a period of **3 months** from the date of delivery and shall test a nd Commission of the entire system at site. If so, required by IREL, the manufacturer's / supplier's trained e ngineer/ technician shall extend necessary technical supervisory supports during installation and commissi oning.

FINAL ACCEPTANCE CERTIFICATE (FAC):

The FAC will be issued by the PURCHASER only on demonstration of the technical specifications. The warranty shall commence only from the date of the issuance of the FAC.

DOCUMENTS TO BE SUBMITTED:

The following documents (in English) shall be provided along with the Unit in both hardcopy and softcopy forms:

LIQUIDATED DAMAGES FOR DELAY IN EXECUTION OF CONTRACT

For delays attributable to the contractor, liquidated damages shall be levied at the rate of @ 0.5% per w eek or part thereof on the total value of the contract subject to a maximum of 10 % of the tot al value of the contract. The liquidated damage will be recovered from any o utstanding bills or amount due to the successful bidder.

WARRANTEE:

The materials/equipments and all accessories supplied shall be warranted against any defective material, malfunctioning or poor workmanship for a minimum period of 12 months from the date of installation and commissioning as indicated in FAC or 18 months from the date of supply, whichever is earlier.

- 1. Definition of Class I and Class II suppliers in the bid not in line with the extant Order / Office Memorandum issued by DPIIT in this regard.
- 2. Seeking EMD submission from bidder(s), including via Additional Terms & Conditions, in contravention to exemption provided to such sellers under GeM GTC.
- 3. Publishing Custom / BOQ bids for items for which regular GeM categories are available without any Category item bunched with it.
- 4. Creating BoQ bid for single item.
- 5. Mentioning specific Brand or Make or Model or Manufacturer or Dealer name.
- 6. Mandating submission of documents in physical form as a pre-requisite to qualify bidders.
- 7. Floating / creation of work contracts as Custom Bids in Services.
- 8. Seeking sample with bid or approval of samples during bid evaluation process. (However, in bids for attached categories, trials are allowed as per approved procurement policy of the buyer nodal Ministries)
- 9. Mandating foreign / international certifications even in case of existence of Indian Standards without

- specifying equivalent Indian Certification / standards.
- 10. Seeking experience from specific organization / department / institute only or from foreign / export experience.
- 11. Creating bid for items from irrelevant categories.
- 12. Incorporating any clause against the MSME policy and Preference to Make in India Policy.
- 13. Reference of conditions published on any external site or reference to external documents/clauses.
- 14. Asking for any Tender fee / Bid Participation fee / Auction fee in case of Bids / Forward Auction, as the case may be.

Further, if any seller has any objection/grievance against these additional clauses or otherwise on any aspect of this bid, they can raise their representation against the same by using the Representation window provided in the bid details field in Seller dashboard after logging in as a seller within 4 days of bid publication on GeM. Buyer is duty bound to reply to all such representations and would not be allowed to open bids if he fails to reply to such representations.

This Bid is also governed by the General Terms and Conditions/ यह बिड सामान्य शर्तों के अंतर्गत भी शासित है

In terms of GeM GTC clause 26 regarding Restrictions on procurement from a bidder of a country which shares a land border with India, any bidder from a country which shares a land border with India will be eligible to bid in this tender only if the bidder is registered with the Competent Authority.
