XII) SPECIAL CONDITIONS OF CONTRACT

1. SCOPE OF CONTRACT/WORK:

The scope of supply includes and not limited to submersible agitator sand /gravel pump as per det ailed specification, terms and conditions furnished in the tender including transportation to OSCOM stores on FOR Destination basis. The supplies include control panel, suitable standard cabl e of min 20m, etc

Unloading will be done at OSCOM stores by IREL

Erection of equipment shall be done by IREL at its site. Required supervisory supports shall be ext ended, if required by IREL

2. Time period of completion:

The order shall be fully supplied within **12 weeks** from the date of placement of order.

3. Terms OF PAYMENT

80% payment along with 100% taxes and duties shall be made towards supply against tax invoice within **4 weeks** of receipt & acceptance of the equipment at IREL, OSCOM Stores.

20% shall be paid after successful commissioning of the **equipment issue of Final Acceptance Certificate (FAC) or within 8 weeks of supply, whichever is earlier** and against receipt of a bank guarantee valid for 12 months from the date commissioning OR 18 months from the date of supply whichever is earlier with an additional claim period of 3 months.

The bidder has to quote terms of price FOR OSCOM unit, Matikhalo, Ganjam Dt, Odisha. The rate o ffered shall include any cost towards extending supervisory supports during installation and comm

issioning, if so required by IREL. The rate quoted shall be in Indian Rupees only.

4. MODE OF PAYMENT:

The payment shall be released after deducting the following:

5. PREDISPATCH INSPECTION

IREL reserves to have pre-dispatch inspection of machines prior to its dispatch. Readiness for predispatch inspection shall be intimated at least 15 days in advance so that IREL (India) Limited can depute its representative and mobilize the required samples for carrying out trial, if any required. On ascertaining the performance of the machines, clearance shall be given for dispatch of the mac hine.

However final inspection shall be done at our stores and this only shall be the basis for final accept ance.

6. PACKAGING SITE HANDLING, STORAGE OF MATERIALS & EQUIPMENTS:

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioratio n, damage or breakage during shipment, handling and storage in a tropical climate, ideally in woo den cartons. All exposed ferrous metal surfaces shall be covered with a suitable rust preventive co mpound of reputed make. Large items shall be individually crated

7. MARKING ON PACKAES:

Each package will be marked on three sides with proper paint/indelible ink, the following (1) Purch aser Name & Address (2) Item Nomenclature (3) Order/Contract No. (4) Packing list reference num ber.

8. INSURANCE:

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or dama ge during transportation/shipment and handling. For delivery of goods to the purchaser's premises , it is advised that insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the goods from "Warehouse to warehouse" (final destinations) on "All Risks" basis includi ng War Risks and Strikes.

9. TRANSPORATION:

Delivery of the equipment/materials to IREL, (India) Ltd, OSCOM, Matikhalo shall be done by the ${\bf c}$ ontractor at their risk and cost.

10. UNLOADING, HANDLING:

Unloading at site shall be done by IREL at its cost.

Any incidental expenses at IREL other than unloading charges shall be borne by the supplier

Procedure for unloading and handling shall be communicated by the supplier to IREL well in advan ce.

11. INSPECTION

The items will be inspected by IREL on receipt at IREL site. You may at your option depute your rep resentative for carrying out joint inspection at site or else IREL may conduct inspection on its own. If it is found that any item does not conform to the specification given, or is defective in any mann er, the same will be rejected and supplier should arrange for immediate replacement thereof, free of cost to us inclusive of all taxes and duties. Such replacement supplies will also be subjected to our inspection as above before acceptance. However, such supplies, if delayed beyond the period of contract will be considered as late supply and will attract Liquidated damages.

12. INSTALLATION / ERECTION

The equipment shall be installed/erected by IREL at its cost

Procedure for handling/erection/installation shall be clearly communicated by the contractor. This shall include timely intimation of civil foundation drawings and details, power and other electrical connection details, etc to be provided to IREL.

If so required by IREL, the contractor shall extend necessary supervisory supports for erection/inst allation at no extra cost to IREL

13. TESTING AND COMMISSIOING:

IREL will install the machine at its site within a period of **8 weeks** from the date of receipt of item at its stores. If so required by IREL, the manufacturer's / supplier's trained engineer/ technician sh all extend necessary technical supervisory supports during installation. IREL shall test and Commis sion the pump in the presences of the bidder, if so they wish to witness.

Any special commissioning spares, tools, tackles required shall be provided by the supplier

Commissioning of equipment means running the submersible agitator pump for 4 hour s continuously to observe satisfactory performance of the equipment.

14. TRAINING

The contractor shall provide necessary training to IREL staff for operation and maintenance of the system. They shall also provide the Operations and Maintenance Manuals, catalogues, etc for the entire system, including brought out major components.

15. FINAL ACCEPTANCE CERTIFICATE (FAC):

The FAC will be issued by the PURCHASER only on demonstration of the technical specifications. T he warranty shall commence only from the date of the issuance of the FAC.

The materials/equipments and all accessories supplied shall be warranted against any defective m aterial, malfunctioning or poor workmanship for a minimum period of **12 months from the date of installation and commissioning as indicated in FAC or 18 months from the date of su pply, whichever is earlier.**

18. OTHER TERMS AND CONDITIONS:

The supplier shall include all other equipment /components/ instruments etc. which are not describ ed herein specifically but are deemed necessary for completeness, safety and satisfactory perfor mance of the supply under their scope.

The equipment's shall comply with the sta tutory requirements of the Govt. of India. The equipment and installation shall conform to the provision of statutory and other regulations in force such Indian Electricity Act etc. The successful bidder shall provide the necessary support like drawings, data etc as required by the statutory aut horities. In cases where the offer deviates from the specified standards, the successful bidder shall indicate clearly in his offer the standards proposed to be adopted by him and the details thereof.
