- 1. XII) SPECIAL CONDITIONS OF CONTRACT

1. SCOPE OF CONTRACT/WORK:

The scope of supply includes and not limited to supply of 750 kVA Unitized substation as per detailed speci fication, terms and conditions furnished in the tender including transportation to OSCOM stores on FOR Destination basis.

Unloading will be done at OSCOM - Central Stores by IREL

Erection of equipment shall be done by IREL at its site. Required foundation drawing, electrical line diagrams, etc shall be timely provided by the supplier .Required supervisory supports shall be extended by the supplier towards erection. Commissioning shall be done by the contractor in presence of IREL.

2. Time period of completion:

The order shall be fully supplied within 6 months from the date of acceptance of order.

3.Terms OF PAYMENT

90% payment along with 100% taxes and duties shall be made towards supply against tax invoice within 3 0 days of receipt & acceptance of the equipment at IREL, OSCOM Stores.

10% shall be paid after successful commissioning of the equipment against receipt of a bank guarantee valid for 12 months from the date commissioning OR 18 months from the date of supply whichever is earlier with an additional claim period of 3 months.

The bidder has to quote terms of price FOR OSCOM unit, Matikhalo, Ganjam Dt, Odisha. The rate offered sh all include any cost towards extending supervisory supports during installation and commissioning, if so re quired by IREL. The rate quoted shall be in Indian Rupees only.

If any bidder proposes for a payment term other than the above, IREL reserves the absolute right to accept or reject the term and decision of IREL shall be final and binding to all the parties. For evaluation of offers, I oading shall be made at the rate of 12% per annum for variations in payment terms.

4. MODE OF PAYMENT:

The payment shall be released after deducting the following:

5. PREDISPATCH INSPECTION

Pre-dispatch inspection of equipments shall be carried out by IREL prior to its dispatch. Readiness for predispatch inspection shall be intimated at least 20 days in advance so that IREL (India) Limited can depute i ts representative. On ascertaining the performance of the equipments, clearance shall be given for dispatc h of the equipments.

However final inspection shall be done at IREL site and this only shall be the basis for final acceptance.

6. PACKAGING SITE HANDLING, STORAGE OF MATERIALS & EQUIPMENTS:

The equipment, material etc. shall be so packed and protected so as not to suffer any deterioration, damag e or breakage during shipment, handling and storage in a tropical climate, ideally in wooden cartons. All ex posed ferrous metal surfaces shall be covered with a suitable rust preventive compound of reputed make. Large items shall be individually crated.

7. MARKING ON PACKAGES:

Each package will be marked on three sides with proper paint/indelible ink, the following (1) Purchaser Na me & Address (2) Item Nomenclature (3) Order/Contract No. (4) Packing list reference number

8.INSURANCE:

The Goods supplied under the Contract shall be fully insured in Indian Rupees against loss or damage duri ng transportation/shipment and handling. For delivery of goods to the purchaser's premises, it is advised t hat insurance shall be obtained by the Supplier for an amount equal to 110% of the value of the goods fro m "Warehouse to warehouse" (final destinations) on "All Risks" basis including War Risks and Strikes.

9.TRANSPORTATION:

Delivery of the equipment/materials to IREL, (India) Ltd, OSCOM, Matikhalo shall be done by the contractor at their risk and cost.

10. UNLOADING, HANDLING:

Unloading at site shall be done by IREL at its cost.

Any incidental expenses at IREL other than unloading charges shall be borne by the supplier

Procedure for unloading and handling shall be communicated by the supplier to IREL well in advance.

11. INSPECTION

The items will be inspected by IREL on receipt at IREL site. You may at your option depute your representa tive for carrying out joint inspection at site or else IREL may conduct inspection on its own. If it is found that any item does not conform to the specification given, or is defective in any manner, the same will be rejected and supplier should arrange for immediate replacement thereof, free of cost to us inclusive of all taxes and duties. Such replacement supplies will also be subjected to our inspection as above before acceptance. However, such supplies, if delayed beyond the period of contract will be considered as late supply and will attract Liquidated damages.

12.INSTALLATION /ERECTION

The equipment shall be installed/erected by IREL at its cost.

Procedure for handling/erection/installation shall be clearly communicated by the contractor. This shall include timely intimation of foundation drawings and details, power and other electrical connection details, et c to be provided to IREL.

If so required by IREL, the contractor shall extend necessary supervisory supports for erection/installation at no extra cost to IREL

13.TESTING AND COMMISSIOING:

Installation of 750 kVA unitized substation will be carryout out by IREL. If so required by IREL, the manufac turer's / supplier's trained engineer/ technician shall extend necessary technical supervisory supports during installation.

Any special commissioning spares, tools, tackles required shall be provided by the supplier.

Commissioning of 750 kVA unitized substation shall be carried out by the contractor at IREL.

14.TRAINING

The contractor shall provide necessary training to IREL staff for operation and maintenance of the system. They shall also provide the Operations and Maintenance Manuals, catalogues, etc for the entire system, including brought out major components.

15. DOCUMENTS TO BE SUBMITTED:

The following documents (in English) shall be provided along with the Unit in both hardcopy and softcopy forms:

18. OTHER TERMS AND CONDITIONS:

The supplier shall include all other equipment /components/ instruments etc. which are not described herein specifically but are deemed necessary for completeness, safety and satisfactory performance of the supply under their scope.

The equipment/components supplied shall have high degree of reliability, the supplier shall offer & supply equipment/components of proven design, excellent workmanship and proven industrial running record. All materials supplied by the contractor shall be of good quality conforming to relevant and applicable standards for use in India and shall be suitable for the service specified.
