

GENERAL INSTRUCTIONS TO BIDDERS

GENERAL

- 1) Bidder should take into account any corrigendum published on the tender document before submitting their bids.
- 2) Please go through the tender advertisement and the tender document carefully to understand the documents required to be submitted as part of the bid. Please note the number of covers in which the bid documents have to be submitted, the number of documents including the names and content of each of the document that need to be submitted. Any deviations from these may lead to rejection of the bid.
- 3) Bidder, in advance, should get ready the bid documents to be submitted as indicated in the tender document / schedule and generally, they can be in PDF / XLS / RAR / DWF/JPG formats. Bid documents may be scanned with 100 dpi with black and white option which helps in reducing size of the scanned document.

PREPARATION AND SUBMISSION OF BIDS

- 1) The tender bids duly filled in all aspects and uploaded at GEM Portal on or before the scheduled time and date as mentioned in the tender enquiry will be considered for evaluation.
- 2) Bidder should log into the site well in advance for bid submission so that they can upload the bid in time i.e., on or before the bid submission time. Bidder will be responsible for any delay due to other issues.
- 3) The Bids shall be prepared in two parts viz. PQ cum Technical Bid (Part-I) and Price Bid (Part-II). The bidder has to digitally sign and upload the required bid documents one by one as indicated in the tender document.
- 4) Technical Bid will be opened at the first instance and evaluated by IREL's concerned authority. In the second stage, financial bids of only the technically eligible offers will be opened for further evaluation and ranking before awarding the contract.

PQ cum Techno-commercial bid (Part -I)

It contains documents in support of eligibility criteria, self-attested tender document and any other document specifically specified in this tender document.

Part -II shall contain Price Bid (to be submitted electronically).

This part shall contain only Schedule of prices duly filled in as per the Bid Proposal Schedules. No physical submission of hard copy is permitted.

5) The uploaded tender documents become readable only after the tender opening by the authorized bid openers.

6) <u>METHOD OF SELECTION</u>:

Part-I of the bid will be evaluated and bidders meeting the PQ criteria and other tender conditions will be qualified as eligible bidders for opening of the price bids. The price bids opened subsequently will be scrutinized for responsiveness and IREL shall consider placement of order on the qualified bidder, whose offer shall be overall lowest. However, IREL reserves the right to accept or reject all or any tender without assigning any reasons and does not bind itself to accept the lowest offer.

Note: To assist in the examination of documents submitted by the bidder in support of eligibility criteria (PQ), IREL may, at its discretion, ask the Bidder for clarification of its bid. The request for clarification and the response shall be in writing and no change in the price or substance of the bid shall be sought, offered or permitted.

7.1 <u>Site Visit</u>:

Prior to quoting rates, the bidders are advised to visit the site on any working days at our specified visiting hours with the permission of Engineer concerned /Purchase Dept. PRE -QUALIFICATION CRITERIA (PQC)

Bidder shall submit copy of AMC/ Work order along with proof of execution/ tax invoice/ work completion certificate for Maintenance of Fire extinguishers as per IS 2190:2010 or latest version along with Technical bid.

1.0 SCOPE OF WORK

Maintenance Contract involves Inspection, Servicing, Replacement of damaged/unserviceable parts, Hydraulic pressure testing, Refilling and Painting of 172 numbers of Fire extinguishers for a period of two years conforming to IS 2190:2010 or latest version in the Plant premises and Administrative building of IREL, RED, Udyogamandal.

2.0 SPECIAL CONDITIONS OF THE CONTRACT

- 2.1 Maintenance Contract (Two years) shall include Inspection, Servicing, Replacement of damaged/unservicable parts, Hydraulic Pressure Testing, Refilling and Painting conforming to IS 2190:2010.
- 2.2 All the 172 fire extinguishers as mentioned in the list given below are to be serviced and refilled as per the statutory requirement.
- 2.3 The Maintenance contract for inspection and servicing of fire extinguishers has to carryout quarterly (once in 3 months interval) and report shall be submitted after the work.
- 2.4 The contractor shall take the fire extinguishers at their site if required and return back after Servicing, Hydraulic Testing, Refilling and Painting of Fire extinguishers within 30 days.
- 2.5 The extinguishers can be taken out by the party for Hydraulic Testing, Refilling and servicing with prior approval of Engineer in-charge (EIC) and stand-by fire extinguishers to be provided to meet the emergencies in plant.
- 2.6 The contractor has to submit Test certificate for fire extinguishers carried out hydraulic pressure test mentioning serial number, type & capacity of fire extinguisher, date of testing, test pressure, inspection result etc.
- 2.7 Fire extinguishers if any rejected during the pressure test will not be considered for payment.
- 2.8 The month in which the Hydraulic Pressure Test was conducted needs to be punched/marked/embossed on the body of the extinguisher (i.e., close to the neck) or else it should be written neatly and clearly in white paint. Test reports for the fire extinguishers have to be submitted.
- 2.9 The inspection and maintenance of Fire extinguisher include cleaning of the cylinder body parts of extinguishers and examination for corrosion/ damage, polish the painted portion with wax polish, the brass/ gun metal parts with metal polish, chromium plated parts with silver polish and plastic components to be thoroughly washed with soap solution and sun dried, examination and cleaning of nozzles, vent holes, siphon tubes, horn & discharge hoses with dry air, grease the threads of cap, plunger, handle etc., weighing of extinguisher to compare the mass of extinguishing medium, examination of pressure gauges.
- 2.10 The Hydraulic Testing and Refilling of identified Fire extinguishers has to be carried out as per the Fire extinguisher desired pressure as mentioned in Annexure E of IS 2190: 2010 and based on requirement of EIC.
- 2.11 Fire extinguishers to be painted in Orange red with super finish.
- 2.12 The contractor has to bring all necessary tools, accessories and equipment's for carryingout the work.
- 2.13 Inspection card shall be pasted on the body of the fire extinguisher indicating the serial number of the extinguishers, date of Refilling & Hydraulic Pressure Testing, month of servicing & inspection, next due month of servicing & inspection and the next due date of Refilling and Hydraulic Pressure Testing.
- 2.14 Party has to quote separately for Maintenance contract charges, cost of the damaged/unserviceable parts to be replaced, Painting, Servicing and Refilling of used Fire extinguishers and Hydraulic Pressure Testing. Party has to submit Maintenance contract bill along with Servicing, Hydraulic Pressure Testing, Refilling charges, Cost of spares replaced and Painting charges as per the price schedule/ tender. Separate payment will be released against spares replaced during service visit.
- 2.15 To and fro transportation of the Fire extinguishers shall be borne by the contractor.
- 2.16 The rates are inclusive of traveling and other expenses of your supervisor along with service team and incidental expenses incurred during the works.
- 2.17 Servicing of the fire extinguishers shall be completed before 20th of the month in which Maintenance contract is due for the particular quarter.

- 4.2 The contractor has to submit a separate bill for Replacement of damaged/unserviceable spare parts, Refilling of used fire extinguishers, Painting and Refilling & Hydraulic Pressure Testing of Fire extinguishers for which due date has been exceeded/damaged after taking prior approval from EIC.

"Day" means a calendar day of 24 hours from midnight to midnight irrespective of the numberof hours serviced in that day.

"Demobilization" means removal of all equipment, machinery, manpower from the site after completion of the services with the due permission of EIC.

"Drawings" means and include all Engineering sketches, general arrangements/ layout drawings, sectional plans, all elevations, etc. related to the Contract together with modification and revision thereto.

The "Employer/Service Receiver/ Company/Owner" means IREI (India) Limited, a PublicSector Undertaking, incorporated under the Company's Act 1956 and having its Registered office at Plot No. 1207, Veer Savarkar Marg, Prabhadevi, Mumbai, Maharashtra-400066 and includes its successors, assigns and Units.

"Fax of Acceptance" means intimation regarding notification of award by the Employer to the successful Bidder/Service Provider through a Fax/ Letter conveying that the Tender/Bid/Offer has been accepted in accordance with the provisions contait theorin

"Guarantee/Warranty/ Defect Liability Period (DLP)" means the period and other conditions governing the warranty/guarantee/defect liability period of the services as provided in the Contract.

"Metric System": All technical documents are given in the metric system and all service should be carried out according to the metric system. All documents concerning the service shall also b emaintained in the metric system.

Mobilization means stabilizing adequate infrastructure at designated Site comprising of Equipment, aids, tools, tackles, instruments, Goods & Materials, experienced manpower, supported with supervising personal in order to provide services as per the provision of Contract document.

The "Service Provider' means Bidder/Tenderer whose tender has been accepted by the Employer and includes the Service Provider's legal representative(s), his successor(s) and permitted assign(s).

"Service Provider's/ Bidder's Representative" means such person(s) duly authorized by the Bidder/Service Provider in writing to the Employer as having authority to act for and on behalf the Bidder /Service Provider in matters affecting the Services and to provide the requisiteservice to Employer. "Site" means the place(s) provided by the Employer where the Services are to be carriedout/executed and any other place(s) as may be specifically designated in the Contract asforming part of the site.

"Specifications" means and include detailed description, statements to technical data, performance characteristics, and standards (Indianas well as International) as applicable and as specified in the Contract.

The 'Sub-Service Provider' means any person / firm / Organization / company /entity (other than the Service Provider) and it's legal representatives, successors and permitted assigns named in the Contract as a Sub-Service Provider for a part of the Services or towhom a part of the Services has been sub-Contracted with the written prior consent of the Employer.

"Value of Contract" or "Total Contract Price" means the sum accepted or the sum calculated in accordance with the prices accepted in the Contract as payable to the Service Provider for the entire execution and full completion of the service, including Amendment(s) to Contract, if any.

"Week" means a period of any consecutive seven Days.

"Willful Misconduct" means intentional disregard of good and prudent standards of performance or proper conduct under the Contract with knowledge that it is likely to resultin any injury to any person or loss or damage of property.

"Working Day" means any Day which is not declared by the Employer to be holiday or off-day

INTERPRETATIONS & PRIORITY OF CONTRACT DOCUMENTS

The documents forming the Contract are to be read together and interpreted as mutually explanatory of one another. If there is a direct inconsistency in specific obligation(s), then for the purposes of interpretation, and unless otherwise provided in the Contract, the priority of the Contract Documents shall be in accordance with following sequence: i)
