If the bidder wants to avail themselves of the Purchase preference, the bidder must be the manufacturer / OEM of the offered product on GeM. **Technical competency:** a) The Bidder or its OEM {themselves or through re-seller(s)} should have supplied heavy duty series 2 ton windows Air Conditioner in any industrial in last five years ending bid opening date to any Central / State Govt. Organization / PSU / Public Listed Company / private organizations. #### **Note:**

The request for clarification shall be given asking the tenderer to respond by a specified date. If the tenderer does not comply or respond by the date, his tender will be liable to be rejected. Depending on the outcome, such tenders are to be ignored or considered further. No change in prices or substance of the bid shall be sought, offered or permitted.
