2. Project Title & Description: "Development of Green Belt & Plantation inside Rare Earths Extracts Plant (REEP) premises on site-specific basis."

The intern will go through the plantation details given in Environmental Management Plan submitted to MoEF&CC. He/She will interact with District Forest Office through IREL's departmental Officer and will select site specific species for tree plantation in vacant/ available places inside REEP boundary. He/She will develop a procedure for maintenance of the same. He/She will play a major role in encouragement/development/involvement of other officials/ contractual persons available in REEP to carry out plantation activities in their respective areas.

- **3. Number of Intern to be taken:** One (01)
- 4. Period of Internship: Maximum period of six months from the date of engagement.
- 5. Stipend: Rs 12000/- (Rupees Twelve Thousand only) per month.
- **6. Requisite Educational Qualification:** Should have passed M.Sc (Botany) or B.Sc (Botany Honours) or M.Sc (Environmental Science) preferably within three years preceding the date of notification.
- **7. Selection Methodology:** The candidates who fulfil the criteria with respect to the educational qualifications may attend the Walk-in-Interview. Selection will be made based on performance during the interview, academic excellence and past work experience, if any. Apart from the subject, knowledge of computer operation, excellent written and oral communication, ability to perform in a dynamic environment and good comprehensive skills will also be given due weightage.
